

**NOTICE TO TAXPAYERS OF HEARING ON PROPOSED LOCAL INCOME TAX  
RESOLUTION**

Notice is hereby given to the taxpayers of the Town of Zionsville, Boone County, Indiana, that on October 11, 2016, at 7:00 p.m., a public hearing will be held at the Herman B. Wells Community Center at Lebanon High School, 510 Essex Drive, Lebanon, IN 46052. At that time, the Town Council of the Town of Zionsville, together with the Common Council of the City of Lebanon and the Town Councils of the Towns of Advance, Jamestown, Thorntown, Ulen, and Whitestown, Boone County, Indiana will each consider a resolution in substantially the following form concerning an ordinance proposed by the Boone County Council modifying the local income tax rates imposed in Boone County.

**A RESOLUTION ON A PROPOSED ORDINANCE MODIFYING  
LOCAL INCOME TAX RATES IMPOSED IN BOONE COUNTY**

**BE IT RESOLVED** by the Town Council of the Town of Zionsville, that a need now exists to modify the local income tax rates imposed within the county. As a member of the Boone County Local Income Tax Council, the Town Council is considering a resolution casting its votes in favor of the ordinance below, as proposed by the Boone County Council, to the members of the Boone County Local Income Tax Council.

***ORDINANCE MODIFYING LOCAL INCOME TAX RATES  
IMPOSED IN BOONE COUNTY***

***BE IT ORDAINED*** by the Local Income Tax Council of Boone County, Indiana that a need now exists to modify the local income tax rates imposed within the county in the following way:

<b><i>Local Income Tax Type</i></b>	<b><i>Existing Rate</i></b>	<b><i>Proposed Rate</i></b>
<i>Expenditure Rate (IC 6-3.6-6)</i>	<i>1.0%</i>	<i>1.5% (0.5% for Public Safety)</i>

*The local income tax rates proposed above will become effective on January 1, 2017.*

*The local income tax rates proposed above will remain in effect until modified or repealed by Boone County Local Income Tax Council.*

***BE IT FURTHER ORDAINED*** that public hearings were held on the proposed local income tax rate modifications on September 13, 2016 and October 11, 2016. Proper notice of the public hearing was provided pursuant to IC 5-3-1.

*Duly adopted by the following vote of the members of the Boone County Local Income Tax Council this \_\_\_\_\_ day of \_\_\_\_\_, 2016.*

**BE IT FURTHER RESOLVED** that by adopting this resolution, the Zionsville Town Council casts all of its 25.00 Local Income Tax Council votes in favor of the proposed ordinance.

**BE IT FURTHER RESOLVED** that a public hearing was held on this resolution and the proposed ordinance on October 11, 2016. Proper notice of the public hearing was provided pursuant to IC 5-3-1.

Duly adopted by the following vote of the members of the Zionsville Town Council this 11th day of October, 2016
