

ORDINANCE NO. 2020 -21

**AN ORDINANCE SETTING THE 2021 TOWN OF ZIONSVILLE,
INDIANA FEE SCHEDULE FOR THE DOG PARK AND AMENDING
THE ZIONSVILLE, INDIANA
CODE OF ORDINANCES**

WHEREAS, the Town of Zionsville Code of Ordinances (“Code of Ordinances”) maintains fees for various items charged by the Town of Zionsville (“Town”) in many sections throughout the Code of Ordinances; and

WHEREAS, the Town proposed to consolidate these fees into one document with the goal of enhancing the ease with which these fees may be reviewed and updated, as appropriate, on a regular basis, the Town has hereby created the attached 2021 Town of Zionsville Fee Schedule which describes many, but not all, of the fees currently collected by the Town; and

WHEREAS, in the year calendar 2021, the Town will begin to collect new fees for the new dog park; and

WHEREAS, the Town Council wishes to amend the originally proposed 2021 Town of Zionsville Fee Schedule to preserve all current 2020 fees and to only add a new fee for the new dog park.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Zionsville, Indiana:

Section 1: The 2021 Town of Zionsville Fee Schedule for the Dog Park, attached hereto as Exhibit A and incorporated herein, is hereby adopted.

Section 2: Any existing Ordinances, or portions thereof, that impose a fee remain at the current rate until further amended or repealed by the Town Council.







Section 5: This Ordinance shall be in full force and effect from and after its passage and approval by the Town Council and the Mayor.


