**OF THE TOWN OF ZIONSVILLE**

**A RESOLUTION DECLARING ITEMS SURPLUS AND AUTHORIZING  
THE DISPOSITION OF SURPLUS ITEMS**

**WHEREAS**, pursuant to Indiana Code § 5-22-22, *et. seq.*, the Purchasing Agency of the Town of Zionsville (the "Town") may sell or otherwise dispose of property that belongs to the Town but is no longer needed or is unfit for the purpose for which it was intended; and

**WHEREAS**, the Department of Finance and Records and the Chief Financial Officer of the Town, as Department Head of the Department of Finance and Records, serves as the Purchasing Agency of the Town; and

**WHEREAS**, the various Town departments, in conjunction with the Chief Financial Officer, have developed a list of items of personal property that are no longer needed by the Town or are unfit for the purpose for which they were intended; and

**WHEREAS**, the list of items attached hereto as "Exhibit A" are those items deemed to be no longer needed or unfit for the purpose for which they were intended and should be declared surplus and disposed of according to Indiana law.








**NOW, THEREFORE, BE IT RESOLVED BY**, by the Town Council of the Town of Zionsville, Boone County, Indiana, as follows:
