STREET AND STORMWATER DEPARTMENT REPORT FOR THE MONTH OF MARCH, 2012

1. **SYCAMORE ST. PATHWAY**

Contingent upon weather delays, all remaining asphalt work is scheduled for completion by April 6th. Beginning the week of April 9th, the concrete curb ramps will be installed, and this project should be substantially complete and officially open to the public by April 13th.

2. **STORMWATER PERMIT ACTIVITIES**

Routine inspections of eight (8) Rule 5-permitted sites were conducted last month. Staff is also collaborating with the Boone County Soil and Water District to promote and facilitate the purchase and installation of rain barrels by area residents wishing to utilize this method to capture and re-use rain water.

Plans for the installation of a rain garden on the north side of the Town Hall are complete and construction should begin in April. Utilizing native plants with the assistance of area residents educated in such materials, the intent of the project is not only to add aesthetically to the entrance into Town Hall, but also to correct long-standing building drainage issues. This project will also help fulfill the Town's Public Education commitment under its NPDES permit as informational signage will be provided.

3. **STORMWATER MANAGEMENT BOARD**

The Board, along with members of the Citizens' Advisory Committee and Town staff will present information and address questions on a proposed ordinance establishing stormwater utility rates and charges at the April meeting of the Town Council.

4. **FIRST STREET PROJECT**

Revisions have been made to the design development plans, and meetings with individual business and property owners are on-going. To-date, five property owners have been individually approached, and approximately half a dozen remain to be coordinated. Upon completion of this series of meetings, appropriate adjustments will be made to the plans and a final public information meeting will be scheduled. It is expected that individual meetings will be complete by the end of April.

5. **DUKE FACILITY RELOCATION**

Duke Energy is scheduled to replace their utility poles beginning at the substation near Turkey Foot Ave. and Temple Ave. all the way to the substation located along Old 106th St. Accordingly, this work will result in new utility poles along First St. through the downtown area. All existing facilities will remain above-ground. This project has been delayed by Duke from its original start time of January for unknown reasons.

6. **STREET REPAIRS**

Rieth-Riley is nearing completion on the repaving and repairing of streets remaining from last year's project. Work has been completed on the reconstruction of portions of S. Ninth St. and Poplar St. The repaving of streets in the Sugarbush subdivision is scheduled to be completed by April 13th. Due to unforeseen pavement conditions in this neighborhood, modifications to the initial approach were necessary; however all cost increases will be contained within budget and the final result will be a vastly improved product over what was previously in place.

Also included in this project was the reconstruction of portions of the Rail Trail and access from Ninth St. as well as from the Nancy Burton parking lot. Construction on this portion is nearly finished, and will be substantially completed and officially opened for public use by April 13th.

Streets under consideration for repair in the 2012 project are currently under review. The final cost-constrained annual program should be developed by the end of April, with a start of construction in June or July.

7. **ANNUAL HEAVY TRASH COLLECTION**

The annual collection of heavy trash items for Zionsville residents in the urban service district has been set for the week of April 30th. This is an opportunity for residents to dispose of non-hazardous household items that are not normally collected with their weekly trash service. Collection will again be on residents' regular trash day during this week. Information and details have been posted on

the Town's web site and will be advertised in the Times Sentinel, and people may contact the Street and Stormwater Department directly for this information as well.

Several years ago an appliance recycling company began to participate in this service which resulted in the removal of any expense to residents for the disposal of refrigerant-bearing appliances. Several other items traditionally sent to landfills were also included in the recycling initiative, which reduced the contract expenses with Ray's Trash Service. Unfortunately, due to lower than expected quantities of said items, this company can no longer justify the time and expense of door-to-door collection of these items at no charge. To mitigate this change, Street Department personnel will collect recyclable items from curb-side and transport them to a semi-trailer located behind Town Hall. There will therefore be no obvious change to the service noticed by the public.

8. SPRING BRUSH AND LIMB COLLECTION

The spring round of brush and limb collection for Zionsville residents in the urban district has been scheduled for the weeks of April 16th and April 23rd. The specific schedule has been posted to the Town's web site and will be advertised in the Times Sentinel. Residents may contact the Street and Stormwater Department for their specific day of collection, and the schedule is attached to this report.

Spring 2012 Brush & Limb Collection

The Town of Zionsville's Street & Stormwater Department will be providing curbside Brush & Limb Collection **beginning Monday, April 16, 2012**. This service provides Zionsville residents in the Urban district a means to dispose of certain Spring pruning and yard debris. We cannot guarantee the collection unless your items are out curbside by 7:30 a.m. on your designated pick-up day.

Limit on size is 6 inches in diameter. Grass clippings, leaves, decorative grass, vines, stumps, root balls, construction lumber, firewood, and wooden fencing material will NOT be collected. Bundling is not required. Limbs up to 6 inches in diameter may be left intact but should be no larger than can be managed by one person.
