STREET AND STORMWATER DEPARTMENT REPORT
ZIONSVILLE TOWN COUNCIL MEETING
APRIL 4, 2011

1. **SR 334 PATHWAY DESIGN**
Design is complete for the pathway and parcel plats are complete for the properties from which new easements of right-of-way will be necessary. Offers should begin to go out to property owners this month, and construction is still planned for 2011. At its March meeting, the Economic Redevelopment Commission voted to approve funding for the construction of this project utilizing TIF revenue.
2. **TURKEY FOOT PATHWAY DESIGN**
Design is on hold for the pathway to be constructed along the east side of Turkey Foot Ave. Preliminary design and estimated costs were developed by the Town Engineering firm for a potential realignment of the intersecting roadways, and were presented to the Safety Board for their consideration. Upon review and discussion, the Safety Board has tabled this item and recommended that the intersection realignment project be reviewed at that time when the Transportation Plan is revisited. Until that time, pathway design will remain suspended.
3. **EAGLE CREEK STREAM BANK EROSION ALONG TEMPLE AVE.**
Work is substantially complete on this project, with the exception of the placement of additional rip rap material at the ends of the new retaining walls. This process has been severely hampered by severe winter weather, but is not critical to the integrity of the new structures.

The system of wire baskets containing rock material is designed with native planting plugs on the face of the wall towards the creek. Due to seasonal

restrictions, the installation of these vegetation plugs will be deferred until next spring.

Given the recent heavy rains and excessive flooding, this project functioned extremely well even in its un-vegetated, incomplete condition and likely prevented the loss of portions of Temple Avenue from washing away.

4. STORMWATER PERMIT ACTIVITIES

On March 24th, Zionsville co-hosted a Watershed Networking session, “Water Words that Work” along with various State agencies. The program was attended by 67 persons, including members of the Town Council, Stormwater Utility Board and Citizens’ Advisory Committee.

5. STORMWATER MANAGEMENT BOARD

The Stormwater Management Board will be holding its next meeting on April 5th in the Fireplace Room of the Zionsville Town Hall to continue discussions on the potential establishment of a utility rate to fund stormwater management within the Town.

6. SR 334 RELINQUISHMENT

A final agreement has been executed by the appropriate local officials and submitted to INDOT for execution by the necessary State agencies.

7. FIRST STREET PROJECT

Requests for Proposals (RFP’s) have been developed to submit to engineering firms for design services on this project, and Town Manager Mitro and Superintendent Lantz met with Councilors Swack and Mundy to review the RFP’s and discuss this process. Upon their concurrence, the RFP’s were sent to eight engineering firms on March 31st, with a required submittal date of April 29th. Currently the project contemplates new storm sewers, sidewalks, curbs, curb ramps, landscaping and lighting along First Street from Sycamore Street at the south to just north of Poplar Street; however, upon selection of a firm, public meetings will ensue to refine the project.

8. BRUSH AND LIMB COLLECTION

The spring round of brush and limb collection for Zionsville residents in the Urban District has been scheduled for the weeks of April 18th and April 29th. The specific schedule will be posted to the Town’s web site and advertised in the Times Sentinel. Residents may contact the Street and Stormwater Department for their specific day of collection, and the schedule is attached to this report.

9. HEAVY TRASH COLLECTION

The annual collection of heavy trash items for Zionsville residents in the Urban District has been set for the week of May 2nd. This is an opportunity for residents to dispose of non-hazardous household items that are not normally collected with

their weekly trash service. Collection will again be on residents' regular trash day during this week. Information and details will be posted on the Town's web site and advertised in the Times Sentinel, and people may contact the Street and Stormwater Department directly for this information.

10. ANNUAL HOUSEHOLD HAZARDOUS WASTE COLLECTION

This annual service for residents to dispose of hazardous household waste has been set for August 27th at the Town Hall, as in previous years. Detailed information will be made available closer to the date and publicized in various media.

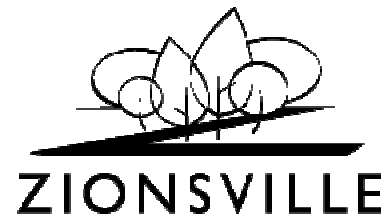
11. DOWNTOWN LANDSCAPE MAINTENANCE

Requests for Quotes were sent to eight area landscape companies to provide landscape installation and maintenance services for the hanging planter baskets, ground landscape islands and general weed control in the Downtown Business District. Upon review of the four firms who submitted by Town Manager Mitro and Superintendent Lantz, a contract has been executed with the Brickman Group to provide said services. The Brickman Group presented the best overall quote in regard to costs, services and professionalism.

12. TRASH/RECYCLING CONTAINERS

Street and Stormwater Department staff has identified several options for new trash and recycling containers for the Downtown Business District. These options will be presented to the Zionsville Merchants' Association at their April 6th meeting for discussion and input. It is hoped that a decision will be made at this meeting, and that the new containers will be ordered this month.

Spring 2011 Brush & Limb Collection

The Town of Zionsville's Street & Stormwater Department will be providing curbside Brush & Limb Collection **beginning Monday, April 18, 2011**. This service provides Zionsville residents in the urban district a means to dispose of certain Spring pruning and yard debris. We cannot guarantee the collection unless your items are out curbside by 7:30 a.m. on your designated pick-up day.

Limit on size is 6 inches in diameter. Grass clippings, leaves, decorative grass, vines, stumps, root balls, construction lumber, firewood, and wooden fencing material will **NOT** be collected. Bundling is not required. Limbs up to 6 inches in diameter may be left intact but should be no larger than can be managed by one person.
