Pursuant to Ind. Code §9-21-1-3.3 and the Town of Zionsville has enacted Ordinance 2019-19 to regulate the operation of golf carts within the Town. You are eligible for registration if your golf cart complies with the requirements of this Ordinance (attached) and you possess a valid permit. Permit is valid for one year starting January 1st and ending December 31st. All permits will renew annually and a new Registration Application will be required. The Zionsville Police Department issues such permits. You must fill out the Registration Application for a permit at the Zionsville Police Department located at 1075 Parkway Drive, Zionsville. The cost of the permit shall be \$100.00 annually and may be paid via cash, credit card, or check made out to the Zionsville Police Department. Pursuant to the Ordinance, all Registrants for a permit **must agree to the following requirements. Please initial to the left of each section in the space provided.** Your initials provide your agreement and attestation to each requirement.

_____ I understand that the operation of a golf cart within the Town is strictly prohibited unless the golf cart is operated and equipped in full compliance with the requirements of the Ordinance. These rules shall not apply to public or private golf courses, constructions sites, retail golf cart outlets, or operation upon private property.

_____ I understand and affirm that I will ensure that Operators of my registered and permitted golf cart must meet the same requirements for operating a motor vehicle found in Ind. Code §9-24-1-1, including but not limited to, having a valid Driver's License and having proof of Financial Responsibility which shall be in the golf cart during all times of operation on Town Streets.

_____ I understand and affirm that I will ensure that Operators of my registered and permitted golf cart shall obey all driver's licensing requirements, Indiana traffic laws, and other related laws and Ordinances and yield the right of way to all pedestrians and bicycles while being driven on Town Streets.

_____ I understand and affirm that I will notify and inform all Operators of my registered and permitted golf cart that the Operator(s) shall stay in the far right of the traveled portion of the road, and yield the right-of-way to an overtaking vehicle as soon as it is possible to do so safely.

_____ As the Registrant, I understand and affirm that I will place the valid Registration Permit issued by the Zionsville Police Department in the upper left-hand corner of the golf car's front frame.

_____ I understand and affirm that a golf cart may not be operated on any Prohibited Streets as that term is defined in the Ordinance. This shall include the following Prohibited Streets:

- (1) 106th Street
- (2) 116th Street
- (3) 300 South
- (4) 96th Street

- (5) 975 East
- (6) Ash Street only from the portion of Mulberry Street to Maple Street
- (7) Elm Street only from the portion of Willow Street to Willow Road
- (8) First Street
- (9) Ford Road
- (10) Maple Street only from the portion of Ash Street to Willow Street
- (11) Mulberry Street
- (12) Oak Street only from the portion of First Street to the corporate town limit
- (13) Sycamore Street only from the portion of First Street to Michigan Road
- (14) Whitestown Road
- (15) Willow Road
- (16) Willow Street
- (17) Zionsville Road
- (18) Main Street from 106th Street to Sycamore Street

And that the term Street only includes such streets in the urban district of Zionsville. I also understand and affirm that any and all Operators may cross a Prohibited Street, at right angles, in order to travel from one (1) Town Street to another Town Street when the operation can be done safely.

I understand and affirm that I will ensure that all Operators shall have no more than the amount of passengers for which the golf cart was originally designed to accommodate or no more than five (5) passengers in the golf cart (whichever is less). The maximum amount of individuals, including the Operator and passengers, in any one golf cart shall be six (6).

I understand and affirm that I will ensure that all Operators shall not allow any open alcoholic containers or illegal substances to be in the Golf Cart at any time during Operation on Town Streets.

I understand and affirm that I will ensure my golf cart has the following minimum safety equipment at all times of Operation and that such minimum safety equipment shall be functional and in use all of the times while the golf cart is in operation on Town Streets. I also understand and confirm that the Town has no legal responsibility for inspecting such minimum safety equipment and proves no assurances and assumes no legal liability for the lack of or failure of such minimum safety equipment or the other equipment or parts of the golf cart.

- (1) Head lights and brake lights; and
- (2) A rearview mirror; and
- (3) A slow moving vehicle sign that conforms to the provisions of Ind. Code §9-21-9-2, affixed to the rear of the golf cart
- (4) A horn

I understand and affirm that all Operators or any person who owns, operates, or rides upon a golf cart on a Town Street does so at his or her own risk and peril, and assumes all liability resulting from such activity. The Town does not assume any legal responsibility or liability under this Chapter by issuing a Registration Permit to an Operator.

_____ I understand and affirm that all Operators provide proof of financial responsibility or a certificate of compliance for the operation of the golf cart on Town Streets upon request of a law enforcement officer.

_____ I understand and affirm that as the Permit Registrant that I am responsible to the Town for payment to the Town for a violation of the Ordinance. I further understand and affirm that such Violations shall result in a fine and/or revocation of my Permit under the following terms:

1. First Offense: \$150.00 fine
2. Second Offense: \$250.00 fine
3. Third Offense and subsequent offenses: \$500.00 fine and revocation of the Registration Permit.

Any second or subsequent offense shall be in the same calendar year.

I, _____ understand the Town of Zionsville, Indiana's "Golf Cart" Ordinance and agree to abide by all rules governing the use of a Golf Cart within the Town limits of Zionsville, Indiana. I understand and affirm that I will comply with the requirements outlined in the Ordinance and this Registration Application. I affirm that the information I have provided is true and accurate, and have tendered payment of \$100.00 for my registration fees pursuant to Ordinance 2019-19.
