ORDINANCE NO. 2013- 17

**AN ORDINANCE OF THE TOWN COUNCIL
OF THE TOWN OF ZIONSVILLE, INDIANA
CONCERNING AN AMENDMENT TO CHAPTER 12 OF THE CODE OF
ORDINANCES FOR THE TOWN OF ZIONSVILLE CONCERNING
STORMWATER QUALITY AND QUALITY MANAGEMENT**

WHEREAS, the Town of Zionsville ("Town") has been declared a Municipal Separate Storm Sewer System (MS4) entity by the Indiana Department of Environmental Management (IDEM); and

WHEREAS, 327 IAC 15-13 required that a MS4 entity adopt a comprehensive Stormwater Management Ordinance for approval by IDEM; and

WHEREAS, the Town adopted Ordinance No. 2004-26 on December 6, 2004 pursuant to such requirement and added a new Chapter 12 entitled "Stormwater Management" to the Code of Ordinances for the Town (the "Code"); and

WHEREAS, the Town desires to amend Chapter 12 of the Code.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, INDIANA THAT:

Section 1. Amendment to Chapter 12 of the Code of Ordinances. The Town Council of the Town hereby deletes in its entirety and replaces Chapter 12 of the Code as provided on Exhibit A attached hereto.

Section 2. Conflicting Ordinances. The provisions of this Ordinance shall be deemed as additional requirements to the minimum standards required by other Town ordinances, if any, and as supplemental requirements to 327 ICA 15-5 (Stormwater Discharge Associated with Construction Activity) and 327 IAC 15-13 (Stormwater Runoff Associated with Municipal Separate Storm Sewer System Conveyances). In case of conflicting requirements, the most restrictive requirements shall apply. The provisions of all other Town ordinances in conflict with the provisions hereof, if any, are no longer in effect and are hereby repealed.

Section 3. Severability. If any part of this Ordinance shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remainder of this Ordinance.

Section 4. Effective Date. This Ordinance shall be in full force and effect from and after the date hereof.


