- 1. Approval of October 2, 2024 meeting minutes; approved 6-0
- 2. Update from Alec Fair
 - a. Alec provided comments on Town Council presentation
 - b. Discussion on 421 land acquisition needed for pathway
 - c. Alec requested suggestions for potential crosswalks needing video
 - i. Crossing Oak/Town Hall
 - ii. 146th near Union
- 3. Reviewed Town Council presentation
 - a. Discussion about Whitestown/Anson pathway is it realistic?
