#### **OLD BUSINESS**

Consideration of an Ordinance to Amend the Zoning Ordinance (Petition 2025-24-OA) Ordinance 2025-12 (Continued from May 19, 2025)

Plunkett All right so we will move on to the first item of Old Business. This is a

Consideration of an Ordinance to Amend the Zoning Ordinance. This is Petition 2025-24-OA, Ordinance 2025-12. This was continued from the May 19<sup>th</sup> meeting

and we have Deputy Mayor Justin Hage with us this evening.

Hage Thank you President Plunkett. [microphone issues]

Burk I don't think so. Talk some more.

Hage [mic not working]

Burk There you go.

McElderry Oh, there you go.

Hage Okay, yes. Thank you President Plunkett. As it was discussed, we continued this

from the last meeting. Still having some very good discussions both to members of Council and with the staff as it relates to putting into operation an amendment that really balances the need for public input while also trying to find some efficiencies as it relates to development plan approvals. We have a call scheduled

tomorrow with leadership of Plan Commission, counsel for the Plan

Commission, counsel for Town Council and Mike Dale from our Planning and Building Department and I think we can find a good solution that we can bring to

you at your next meeting on the 16<sup>th</sup>.

Plunkett Very good. Any questions from Councilors?

Melton Just a comment that we've had some good feedback back and forth trying to keep

it very, as, as he mentioned, public input is important but if the public input doesn't really make any change during the actual vote in those cases, it, it's just been really good to try and find that balance. I think we're pretty close on finding

that and still being very transparent at the same time. So I appreciate the

Administration's willingness to continue those conversations.

Hage Thank you and as Councilor Melton said, I think the other thing we're trying to

balance too is not having too much delay for petitioners as well and I think we

found a, a happy medium that I think we will meet all of our needs so.

Norris Can I ask just a couple real quick?

Plunkett Yes.

Norris The, the development plan process though, like that typically, that's something

that doesn't go before this Town Council, correct?

Hage Correct.

Norris Okay so this is, we're talking about something purely administrative and then

Planning Commission?

Hage Correct.

Norris Not something that we do internally, correct?

Hage That is correct.

Norris Okay. I just want to make sure that I was reading this all correctly. Another issue

just for my purposes, under 194.125 Section 2(B), the administrative approval of redevelopment of existing sites – what is that referring, what's an existing site? So are we saying like if we have a 300-acre development and somebody wants to redevelop it, not do a zoning change or anything like that, the Administration has

the authority to just sign off on that?

Hage No, I think it's a good question and we did, that is one of those categories I think

we're actually going to strike that one -

Norris Okay.

Hage And we're really just going to limit it more to those minor, which is 50% or less,

or those ones that are already there's an existing definition of minor which is that which does not change the square footage and so we're gonna fold it into that

part of the code.

Norris Okay. Thank you. Perfect. That was my concern.

Plunkett Justin, my question here is since this is going to have to go back to the Plan

Commission anyway, should we just deny this now or do you want us to continue it to the next meeting? Like if we deny it now, we work on this and then you get

it to them then it could be in front of the Plan Commission in mid-June.

Harris Except if we deny it we have to have a, a reason for the denial and state that in

writing.

Plunkett Well I could type something up saying we're still working on it and then have it

just lower on their agenda so that they can actually hear –

Harris I would maybe make a recommendation not to do that and go ahead and continue

it because I think we're having some dialogue about maybe bringing back either suggested recommendations that we could then approve here and then it could

just go back to the Plan Commission for ratification.

Plunkett With those changes?

Harris Yes.

Plunkett Okay, perfect. All right.

#### **NEW BUSINESS**

#### Consideration of a Right of Way Vacation (Wild Air) (Public Hearing)

Plunkett First item of New Business is a Consideration of a Right of Way Vacation. This

is Wild Air. We have Roger Kilmer, Senior Planner, Planning and Building Department, also Ryan Weyer from Old Town Homes or Old Town Companies as well. I will note this is a public hearing. At this point I'll open the public hearing. Is there anyone from the public who would like to comment? I'll close

the public hearing.

Kilmer Good evening Councilors. My name is Roger Kilmer, Senior Planner for the, for

the town here really just to introduce and maybe further clarify what is about to be presented by the, the developer. While it has been noted as the request for right of way vacation, what is being requested is actually a reduction in the width of an easement, not a right of way but, but an easement but through language it's, that is known as a public way and so, therefore, that's why it's coming before you so with that little bit of clarification, I'll now introduce Ryan Weyer from

Old Town to further describe the petition.

Weyer Thank you Roger. Ryan Weyer with Old Town Companies. Yes, we're

requesting to reduce a 30-foot easement down to 20 foot. There's a section in the northwest corner of the multi-family portion of Wild Air that is currently 30 foot. The rest of everything along Marysville is 20 and when we moved the or

The rest of everything along Marysville is 20 and when we moved the or installed our, in the process of installing the roundabout we also moved that

further west so between that, the drainage easement that is there that is now all piped, we don't see a need for a 30-foot-wide easement in that northwest corner and it would be consistent all along Marysville if it was reduced to 20.

Burk Is it – go ahead –

Plunkett Go ahead.

Burk Is it just about consistency or is there a scenario where you now need to get into

that easement for some other, for the roundabout or something that you're

building?

Weyer The north, the for, far northwest corner we do have one building that overlaps

into that easement. I believe it's like 8 feet currently.

Sampson In the planning documents that were presented then it was just overlooked that

the easement changed from 20 to 30?

Weyer It was in the planning documents and yes, I just didn't do this process prior to

that but it, that has never changed in the plat, the primary plat.

Burk Roger, if I could ask you, is there any, I mean obviously we're shrinking the

easement. Is there any concern amongst the town that they felt like they needed 30 feet as opposed to 20 feet? Do you see any scenario here where you wouldn't be able to get equipment in there that you would need to if you had to if it were

only 20 as opposed to 30?

Kilmer No, there is no objection from any of the town departments on, on this requested

reduction.

Burk Thank you.

Plunkett Any other questions from Councilors? I would, let's see – so this is, this is one

vote so this is one, one approval so I would make a motion to approve the right of

way vacation.

Norris Second.

Plunkett Second from Councilor Norris. All those in favor signify by saying aye.

All Aye.

Plunkett Those opposed same sign.

# Consideration of a Resolution Regarding the Appropriation of Additional Funds (Community Crossings Grant) Resolution 2025-06 (Public Hearing)

Additional Funds. This is for the Community Crossings Grant, Resolution 2025-06. This is also a public hearing. I have proof of publication of the public hearing. I'll open the hearing. Is there anyone from the public who would like to speak? Seeing none, I will close the public hearing. We've got a memo in the packet that just simply states the purpose of the additional appropriation is to appropriate Community Crossing matching grant funds received from the state to fund a portion of the 2025 road resurfacing and repair projects. If there are questions, certainly Cindy's here to walk through it but if there are no questions, I would entertain a motion.

Sampson Is this the amount that you got Lance from your? Yes, he's nodding yes. Okay.

No questions.

Plunkett All right, this is a resolution so this is a one vote resolution here. I will make a

motion to approve Resolution 2025-06.

Melton Second from Councilor Melton. All those in favor signify by saying aye.

All Aye.

Melton Those opposed same sign.

#### **OTHER MATTERS**

Plunkett Up next on the agenda is Other Matters and I just want briefly to introduce the

idea and I'm gonna have Heather walk through what this would mean for us of a consent agenda. The first, you guys will all notice the first four items on our agenda were the memorandas and the claims and the consent agenda could just simply be an opportunity for us to speed this up a little bit and so Heather, if you

want to -

Harris Yes –

Plunkett Talk about that a little bit.

Harris In just thinking about ways that we can continue to create efficiencies, what we

would do is create a standing consent agenda that would include the minutes and claims or any other sort of item that just requires approval. Sometimes we'll have something that the Town Council President has to sign that's an agreement or a settlement or something like that but you're not really taking a vote on it and then what you could do is just simply make a motion on the consent agenda, a second and then approve it in one vote so you'd be approving multiple items instead of having a vote for each. If you had any questions, concerns, or anybody wanted to talk about an item you can just pull it out of the consent agenda. We think it'd

just keep things moving and we'd get straight into business versus some of the more administrative items so.

McElderry So at what point will we need to pull it out? How early would you need to know?

Harris Just at the beginning of the meeting.

Yes and if there are modifications like, for example, in the minutes from the previous meeting if we need to make a correction, those corrections can be made in the meeting so we can approve the consent agenda with the modifications to the language. I just, it's rare that we get four or five of these at the beginning of a meeting but it's also procedurally if we have online meetings or virtual meetings or something like that it's just a lot easier to streamline the process so. If you guys, if you guys are not opposed to that, Heather and I will likely start making

that adjustment to the -

Harris July meeting –

Plunkett Meetings for July to the minutes so.

Stein Is there anything, well, sorry – would the consent agenda be made available also

to the public through -

Harris Yes.

Stein Okay.

Harris It would just be listed, same link that Amy provides –

Stein Yep –

Harris Everything would be the same, it'd just be one vote versus four or five.

Stein Yes, I just didn't want anybody accusing us of not being transparent.

Harris No, no, we would have all of the same information posted, it's just really a one

vote versus each one separately. It won't save us tons of time but it might save a

little.

Plunkett Questions from Councilors? Comments? All right. Anything else from other

Councilors?

Norris Yes, I'd like to first say thank you to Jarod and his team – they had a great outing

on Friday over at Mulberry Fields. There was a great celebration for all the school kids and I think it was very well attended from what I could tell after 3:00 so kudos to you all for, for a great event on Friday and then also I believe it'll be coming up probably, probably at our next meeting here the Safety Board with Councilor Sampson and Councilor Stein and myself, we voted to make a recommendation for an additional \$150,000 appropriated for the, the Fire Department for overtime. If I'm correct, we had the first mandatory call, callout which is really concerning to me and I'll probably talk to more of you about that

but we had our first mandatory callout that was forced upon one of our firefighters this past Monday, Memorial Day, last Monday, so and he talked to me about that and he was very open to me about it so I think it's really important and can't wait to, to talk to you all further about that and you can feel free to ask Sarah or Joe as well about how they feel about it as well so. Thank you.







**Ordinance Amendment** 

Planning and Building Staff have been working on crafting revisions to several sections of the zoning ordinance over the past few months. This proposed text amendment would revise Sections 194.125-128. This section establishes the procedures for reviewing and approving development plans throughout Zionsville's planning and zoning jurisdiction.

This amendment would not impact the BZA's role is reviewing/granting variances. Variances to development standards would still be appealed to the BZA.

The proposed amendment is intended to repeal and replace the existing sections in the zoning code.

#### Plan Commission Recommendation:

At its April 21, 2025 regular meeting the commission heard Petition #2025-24-OA and upon hearing the request and holding a public hearing, the commission determined 6 in favor/0 opposed to forward a favorable recommendation to the Town Council. #### ORDINANCE NO. 2025- 12 OF THE TOWN OF ZIONSVILLE, INDIANA

#### AN ORDINANCE TO AMEND THE ZONING ORDINANCE FOR THE TOWN OF ZIONSVILLE, BOONE COUNTY, INDIANA

## AND FIXING A TIME WHEN THE SAME SHALL TAKE EFFECT

## Plan Commission Petition No. 2025-24-OA

WHEREAS, the Town Council of the Town of Zionsville, Boone County, Indiana (the "Town Council") desires to promote positive development in the community; and,

**WHEREAS** from time to time it is necessary to review and update the Town of Zionsville Zoning Ordinance (the "Zoning Ordinance"); and,

WHEREAS, the Town Council desires to promote the health, safety, convenience, and general welfare of the community by amending the Zoning Ordinance; and,

**WHEREAS**, in accordance with Ind. Code § 36-7-4-600 *et seq.*, the Town of Zionsville Advisory Plan Commission, Boone County, Indiana (the "Plan Commission") conducted a public hearing on April 21, 2025 to consider a proposal to amend the Zoning Ordinance""; filed as petition 2025-24-OA; and,

**WHEREAS**, the Plan Commission certified the proposal to amend the Zoning Ordinance to the Town, with a favorable recommendation on April 21, 2025 (Exhibit A); and,

WHEREAS, the Town Council considered the Proposal to amend the Ordinance at its regular meeting on \_\_\_\_\_\_, 2025 and,

WHEREAS, the Town Council accepts the recommendation of the Plan Commission and has decided to adopt the proposed amendments to the Zoning Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, BOONE COUNTY, INDIANA, IN ACCORDANCE WITH Ind. Code § 36 7-4-600 et seq., AND ALL ACTS AMENDATORY AND SUPPLEMENTAL THERETO, AS FOLLOWS:

Section 1. The forgoing recitals are incorporated herein by this reference.

<u>Section 2.</u> Sections 194.125 through 194.128 inclusive of the Zoning Ordinance are hereby repealed in their entirety and replaced as follows:

#### § 194.125 DEVELOPMENT PLANS.

#### 194.125

A. Applicability: the development plan review process is established to assure adherence to standards contained in the zoning ordinance. Development plan approval is required prior to the start of any:

- 1. New construction
- 2. Building additions
- 3. Redevelopment of existing sites
- 4. New or expanded surface parking and/or loading areas
- 5. Projects pertaining to Agribusiness Type 1 and 2

#### B. Exceptions:

- 1. Individual single family dwellings
- 2. Agricultural sites and buildings used solely for agricultural purposes
- 3. Temporary land uses or structures
- 4. Establishing a new land use or changing an existing land use
- 5. Projects involving building additions *only* and that do not increase the existing building size by more than twenty-five percent (25%)
- 6. Signs not submitted as part of an overall signage master plan
- 7. New residential subdivisions. These are reviewed and approved via the Subdivision Platting process

#### C. Authority

- 1. The Plan Commission has authority to review and approve development plans specifically assigned to it by this ordinance.
- 2. The Director of Planning and Building (Director) has the authority to review and approve development plans specifically assigned to the Director by this ordinance
- 3. The Director has the authority to determine the appropriate body for approval for those proposals not specifically assigned herein. Any determination by the Director of Planning and Building may be appealed to the BZA in accordance with established rules.

#### D. Application

- 1. Plan Commission review and approval of development plans shall be required for:
  - a. Preliminary plans filed for Planned Unit Developments
  - b. New construction in non-residential zoning districts
  - c. Additions or expansions of any existing non-residential use or structure including outdoor storage or sales areas, parking spaces, or paved surface parking areas by **more than** fifty percent (50%) of its current size, or if any action is required by the BZA and is greater than twenty percent (20%) of the current size
  - d. Addition of any vehicular access point to any existing public right-of-way

- e. Projects related to Agribusiness, Type 2.
- f. Institutional Use Master Plans. In certain cases, an institutional use (school, place of worship, hospital, government entity, etc.) may submit a development plan, showing the locations of all proposed buildings, signage, landscaping, lighting, parking areas, and access points for review and approval.
- 2. Administrative review of development plans shall be required for:
  - a. Secondary review of any Planned Unit Development
  - b. Redevelopment of existing sites
  - c. Additions, expansions, or removal of any existing non-residential use or structure including outdoor storage or sales areas, parking spaces, or paved surface parking areas by **less than** fifty percent (50%) of its current size, or if any action is required by the BZA and is less than twenty percent (20%) of its current size
  - d. Projects related to Agribusiness, Type 1
  - e. Projects included in an Institutional Use Master Plan that do not modify the original master plan by more than twenty-five percent (25%)
- 3. The Director, in their sole discretion, may require projects to be approved by the Plan Commission.
- E. Approval process. Applications for development plan approval shall be filed and processed in the following manner:
  - 1. Anyone wishing to file for development plan approval must schedule a pre-filing meeting with Planning and Building staff to review preliminary plans and discuss the approval process. The need for additional information may also be noted at this meeting. This meeting must occur two (2) weeks prior to the filing deadline noted on the Plan Commission Deadlines and Meeting Dates calendar. In special circumstances, and at the discretion of planning staff, the date for the pre-filing meeting may be less than the two (2) week deadline.
  - 2. File the required application forms, supplementary documents, and fee no later than 3:00PM on the filing deadline noted on the Plan Commission Deadlines and Meeting Dates calendar. Incomplete and/or late applications will not be considered but may be re-submitted on the following filing deadline.
  - 3. Each development plan petition will be reviewed for compliance with the standards set forth in the zoning and subdivision control ordinances. Plans filed for Plan Commission consideration shall be placed on the agenda in accordance with the adopted Plan Commission Rules and Procedures. Plans filed for consideration may also be reviewed at a Technical Advisory Committee Meeting. The purpose of this meeting is to allow the applicant to discuss the project with staff and other commenting agencies prior to any hearings for approval. The applicant may revise plans based on this discussion.
  - 4. Filing Requirements. An application for Development Plan Review shall be made on a form provided by the Planning and Building Department. The application, along with relevant documents and fees, shall be submitted by the deadline noted on the approved Plan Commission Deadlines and Meeting Dates schedule. The proposal shall be reviewed and approved either by the Advisory Plan Commission at a scheduled meeting or administratively.
  - 5. Approval.

- a. Administrative approval. For projects delegated to staff, once staff determines that all technical comments have been resolved, the plans shall be approved. The Director shall sign and date a completed Findings of Fact and approved set of plans, referencing any variances, special exceptions, and commitments. This becomes the official approved Development Plan. A public hearing is not required for administrative approvals.
- b. Plan Commission approval. For projects delegated to the Plan Commission, Commissioners will receive the filing and determine that all technical and development requirements have satisfied, and that the proposal meets the town's adopted development requirements. Approved Findings of Fact shall be signed by the President and this, along with the plans, variances, special exception, and commitments becomes the official approved Development Plan. A public hearing is required for Plan Commission approvals.
- 6. Approval Criteria. Development plans shall be approved only upon making written findings that the Development Plan complies with the following:
  - A. Is consistent with The Town of Zionsville Comprehensive Plan;
  - B. Satisfies the development requirements specified in the applicable zoning ordinance;
  - C. Satisfies the construction requirements of the Zionsville Standard Details.
- 7. Amendments. An approved Development Plan may be approved administratively when the proposed amendment is not a substantial change from the originally approved plans as determined by the Director. The Director may refer plan amendments to the Plan Commission for approval. When evaluating an amendment, it is not necessary to bring the entire site into compliance with current development standards if the amendment involves a less than seventy-five percent (75%) expansion or increase in site intensity.
- 8. Expiration. Development plan approvals shall be valid for three (3) years from the date of approval. The Director many allow one (1) six-month extension for cause. The Applicant shall submit the request in writing and the Director shall make a written determination regarding the decision. The request and decision shall become part of the official record. If substantial progress in developing the project has not occurred by the end of the three year period (or extension), the approval shall expire, and a new application shall be required.
- 9. Appeals of Determinations by the Director: Any determination of the Director under this Section may be appealed to the Plan Commission, in writing, by any interested party. The request must be made by the filing deadline on the official Schedule of Meetings. The applicant shall be responsible for providing Notice per the Rules and Procedures and must attend the meeting where the appeal is being heard.
- 10. Judicial Review. Decisions by the Plan Commission shall be subject to judicial review as per I.C. 36-7-4-1600 Series Judicial Review.
- 11. Waiver of requirements. Neither the Director nor the Plan Commission shall have the authority to waive or modify any development standard of the zoning ordinance in the review of a development plan. All variances from the terms of this Section shall be subject to the approval of the Board of Zoning Appeals.
- 12. Approval of a development plan does not authorize any construction activity, but merely authorizes the applicant to proceed with filing necessary construction and building permits.
- F. Plan Documentation and Supporting Information. Applications for development plan approval shall be filed and processed in the following manner:

- 1. File the required application forms, supplementary documents, and fee no later than 3:00PM on the filing deadline noted on the Plan Commission Deadlines and Meeting Dates calendar. Two (2) paper copies and one (1) electronic copy of all filing materials, including supplemental information is necessary to ensure a complete application. Incomplete and/or late submissions will not be considered but may be re-submitted on the following filing deadline. At a minimum, plans must include the following:
  - a. a signed and completed application and filing fee
  - b. a legal description of the property
  - c. two (2) paper copies and one (1) electronic copy of all filing materials, including supplemental information
  - d. completed Findings for development plan approval
  - e. a project narrative which fully describes the project scope and elements
  - f. a letter granting authority to an agent if the application is not the owner of the property.
  - g. full size plan sets of the development plan to include:
    - i. general vicinity map
    - ii. property boundary lines including any easements
    - iii. elevation marks and contours
    - iv. traffic and circulation plan. This may include a traffic impact study or analysis when required
    - v. pedestrian circulation plan
    - vi. adjacent streets
    - vii. parking and loading plan, including number of spaces required and provided and their dimensions
    - viii. landscape plan indicating plant types (scientific and common names), number, size, location, and installation methods. Notes indicating how proposed landscaping meets ordinance requirements must be included. A tree survey and protection methods must be shown if existing trees are intended to be preserved
    - ix. grading and drainage plan in accordance with stormwater and zoning ordinance requirements
    - x. utilities plan
    - xi. lighting plan
    - xii. size and location of all monument signs. Note: signage is approved through a separate permit process after development plan approval is given
    - xiii, open space and amenity area details
    - xiv. waste receptacles and outdoor storage areas including elevations and building materials

xv. all proposed improvements showing locations, dimensions, and configuration of existing and proposed buildings, structures, and uses

xvi. floor plans, building plans, color elevations, and building materials for all structures

xvii. development summary indicating lot area, building square footages, lot coverage, building heights, number and size of dwelling units and structures.

<u>Section 4.</u> Savings Clause: If any title, section, subsection, phrase, clause, sentence, or word of this Ordinance shall for any reason be held invalid or unconstitutional by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and effect.

<u>Section 5.</u> Construction of Clause Headings: The clause headings appearing herein have been provided for convenience and reference and do not purport and shall not be deemed to define, limit or extend the scope or intent of the clause to which they pertain.

<u>Section 6.</u> Repeal of Conflicting Ordinances: The provisions of all other Town ordinances in conflict with the provisions hereof, if any, are of no further force or effect and are hereby repealed.

<u>Section 7.</u> Severability: If any part of this Ordinance shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remainder of this Ordinance.

<u>Section 8.</u> **Duration and Effective Date**: The provisions of this Ordinance shall become and remain in full force and effect upon adoption according to Indiana Law and until its repeal by ordinance.

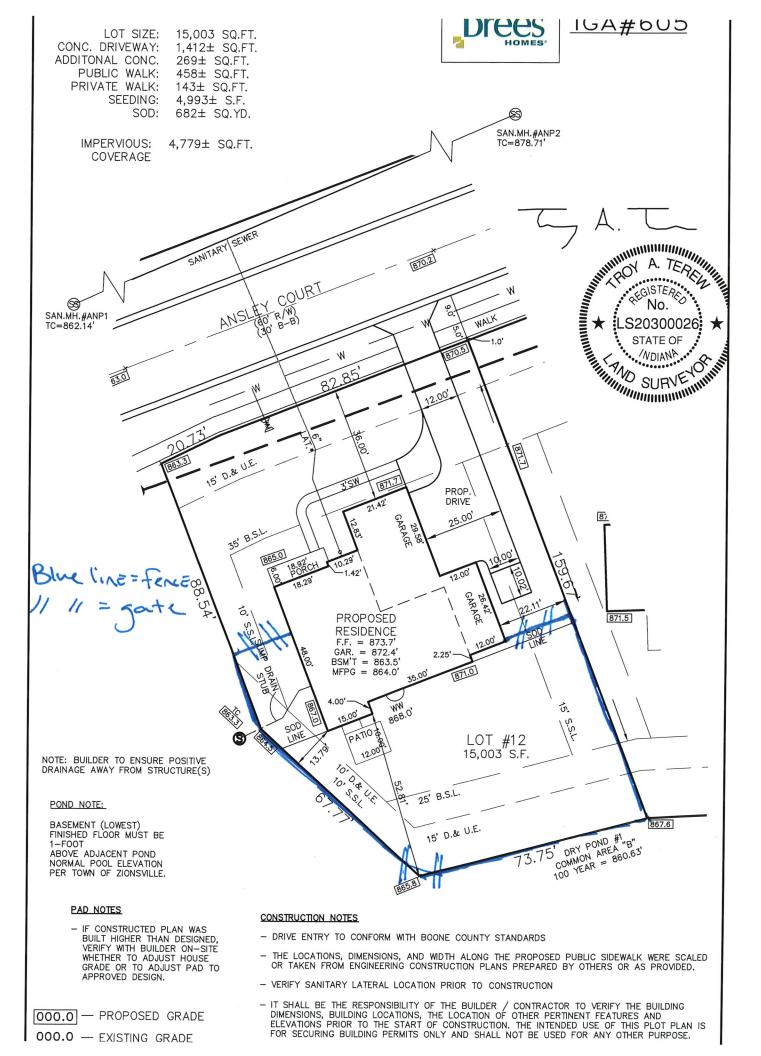

In the event it becomes necessary for the Town of Zionsville to enforce this indemnification and hold harmless provision, the Owner shall pay all reasonable costs the Town incurs in the enforcement thereof and in the enforcement of this Encroachment Agreement, including reasonable attorney fees. 


SUBJECT: Drainage Easement Encroachment Request – 11651 Ansley Ct.

The DPW does not generally support drainage easement encroachments to best preserve their functions, character, and protect them from alterations that could interfere with the flow of stormwater, damage to infrastructure, or create impacts on or to adjacent areas. There should be highly unique situations or extreme hardships before considering any exception to the rules and regulations.

When asked to consider relief from the ordinance, staff visits and reviews a site for three criteria to determine how essential the drainage easement(s) is or are to the stormwater system function:

- Presence of underground pipes 12" or larger.
- Shaped or graded overland conveyance (swale or ditch).
- Identified as an overland flood routing or staging area.

In this instance, there is a 24" concrete storm sewer pipe running along the southwest side property line within the side yard easement, and no structures should be placed within this easement. Should the council be inclined to acknowledge a partial request, the DPW would not object to an encroachment into the rear yard drainage easement, generally depicted by the red line in the image below, subject to the provision that the post holes within the rear yard easement are hand dug and inspected by Stormwater Div. staff prior to post placement.

Re: Request for additional appropriation

The Fire Department is requesting an additional appropriation of \$150,000 towards our overtime budget.

As you know, staffing levels continue to be a concern for the fire department. We currently do not have staffing available to run our fire suppression units at the industry standard of 4 firefighters per unit. The Zionsville Fire Department will not operate a fire suppression unit with less than 3 firefighters assigned to it. Operating at this minimum staffing level has a negative impact on the firefighters, both physically and mentally, while operating on an emergency incident.

The Fire Department has been discussing our staffing needs for the past three (3) months at our regular Safety Board Meetings. At these meetings, Safety Board members asked for a plan to begin to address the shortages in a manner that would not overwork the current short-staffed firefighters. The plan that was developed and approved by the Safety Board would utilize overtime pay to fill one position on a fire suppression fire apparatus for the final six (6) months of this year.

Working to identify funding options, Fire Department Administration met with the Department of Finance and Records and reviewed our potential funds. The Fire Department Operating Fund is projected to have approximately four (4) million dollars at the end of 2025. Therefore, we are recommending the funds for the additional appropriation come from the Fire Operating Fund.

This request was formally introduced at the May 19<sup>th</sup> Safety Board meeting and approved to forward the recommendation to the full Town Council for the June 16<sup>th</sup> Council meeting.
