OF THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, INDIANA

A RESOLUTION TO OPT-IN FOR MEIJER OPIOID SETTLEMENT

WHEREAS, the Town of Zionsville “Town” is a member of the national consortium of law firms representing municipalities in opioid litigation; and

WHEREAS, the Town Council, upon the advice of outside legal counsel on behalf of the national consortium, legal counsel to the Town of Zionsville and at the request of the administration, is opt-in for a settlement in the opioid litigation against defendant Meijer, Inc. as part of a regional proposed settlement in select states and including Michigan, Kentucky, Indiana, Illinois and Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Zionsville, Boone County, Indiana, meeting in regular session and having considered whether to elect to opt in to the proposed settlement in opioid litigation against defendant Meijer, Inc. as part of a regional proposed settlement in select states and including Michigan, Kentucky, Indiana, Illinois, and Ohio, hereby resolves that the Town now exercises its election to opt in to the Meijer opioid settlement, and orders its duly authorized agent to submit a certified copy of this Resolution, if necessary and applicable, to the defendant as part of national consortium of law firms representing the Town and other municipalities in this litigation.
