

**RESOLUTION NO. 2023-05**  
**OF THE ZIONSVILLE TOWN COUNCIL**

**A RESOLUTION ESTABLISHING  
A CROSSWALK LOCATION  
IN ZIONSVILLE, INDIANA**

**WHEREAS**, Title VII, Chapter 70, §70.29 of the Zionsville Code of Ordinances authorizes the Town Council to designate crosswalks and establish safety zones, and

**WHEREAS**, the Indiana Traffic on Uniform Traffic Control Devices (IMUTCD) provides guidance in Section 4C.05 *et seq* quantifying signalized pedestrian crossing warrants, and

**WHEREAS**, the Department of Public Works has incorporated the methodology of the IMUTCD to establish localized data thresholds and evaluation criteria to evaluate crosswalk locations, and

**WHEREAS**, The Department of Public Works scored the location against evaluation criteria, collected crossing pedestrian count data at the intersection of South Ford Road and Starkey Avenue/Continental Drive, evaluated the physical characteristics of the intersection, and finds this location to meet all locally established current criteria as a warranted and justified marked crosswalk.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Zionsville, Boone County Indiana that the Town Council formally establishes a crosswalk on and across the northern leg of the intersection of South Ford Road with Starkey Avenue/Continental Drive and directs the Department of Public Works to procure and install appropriate pedestrian crash countermeasures and undertake the necessary modifications to ensure compliance with applicable standards for construction.
