<u>Section Three</u>. Any officer of the Town be, and hereby is, authorized, empowered and directed, on behalf of the Town to take any other action as such officer deems necessary or desirable to effectuate the foregoing resolution, and any such other actions heretofore made or taken be, and hereby are, ratified and approved.
