RESOLUTION NO. 2021- 06 A RESOLUTION OF THE TOWN COUNCIL TO PROCEED WITH LAND ACQUISTION OF PARCELS FOR PUBLIC PURPOSE

WHEREAS, the Town Council of the Town of Zionsville, Indiana ("Town Council") has determined that it is in the best interest of the Town of Zionsville, Indiana ("Town") to approve the design work, right of way acquisition and property acquisition for the conversion of an existing, signalized intersection at the intersection of Oak Street and CR 800 E./Kissel Road (the "Project"); and

WHEREAS, the Town Council finds that it is in the public interest of the citizens of the Town to consider such Project; and

WHEREAS, the Project is also expected to include a 15-foot multi-use path; and

WHEREAS, the Town has worked to facilitate the acquisition of certain real property, including various rights-of-way, together with all of the necessary appurtenances and related improvements and equipment in, serving or benefiting the Project; and

WHEREAS, the Town intends to comply with the provisions of Ind. Code §36-1-10.5-1 *et seq.* to ensure that any real property having a total price (including land and structures, if any) of greater than twenty-five thousand dollars (\$25,000) has been or will be subject to two appraisals and will not be purchased at a price greater than the average of the two appraisals unless court mandated to acquire the land at a higher price.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Town Council of the Town of Zionsville, Boone County, Indiana:

Section 1. Properties to Be Acquired. The following properties each are proposed to be acquired by the Town have an anticipated purchase price of greater than twenty-five thousand dollars (\$25,000) and are proposed to be acquired by the Town:
