**A RESOLUTION REGARDING
THE APPROPRIATION OF
ADDITIONAL FUNDS**

Whereas, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual Town of Zionsville budget.

Now, therefore, be it resolved by the Zionsville Town Council of the Town of Zionsville, Boone County, Indiana that for the expenses of the Town of Zionsville, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:

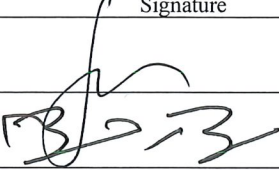
Funds noted above are available for additional appropriation via a June 16, 2022, cash balance in the:

- Motor Vehicle Highway Fund of \$3,465,851.61. The purpose of the additional appropriation is for new right of way necessary for construction of a roundabout at CR 800 E. and Oak St.
- Road Impact Fee Fund of \$2,838,064.02. The purpose of the additional appropriation is to fund a tree and vegetation clearing contract to allow utility relocation activities to proceed.

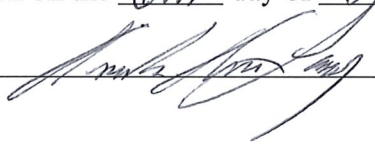

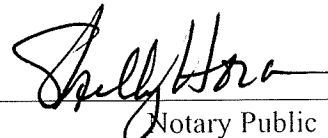

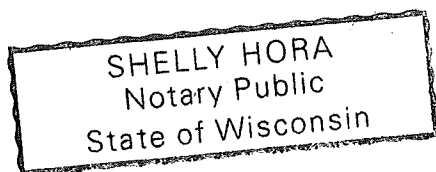
