A RESOLUTION ESTABLISHING A POLICY FOR ELECTRIC FUND TRANSFERS FOR THE TOWN OF ZIONSVILLE

WHEREAS, the Chief Financial Officer of the Town of Zionsville, Indiana ("CFO") finds it necessary and efficient to use Electronic Funds Transfer (EFT) including online banking transfers for payment of claims, pursuant to Indiana Code § 36-1-8-11.5; and

WHEREAS, the Town Council of the Town of Zionsville, Indiana now determines that it is reasonable and appropriate to authorize an EFT method of payment of claims pursuant to Indiana Code.

NOW THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Town Council of the Town of Zionsville, Indiana as follows:

Section 1: Electronic Funds Transfers (EFT) Including Online Transfers. The Department of Finance and Records is authorized to use an electronic funds transfer method of payment of claims/invoices. This is not to supersede the claims process, claims must still be presented to Town Council. Once claims have been approved, the Finance Department will pay those vendors who have provided their banking information, via EFT within two business days, unless the approval date is followed by a holiday, in which case, the Finance Department has two business days following the holiday.

Section 2: Definition of Electronic Funds Transfer. Pursuant to Indiana Code § 36-1-8-11.5(a), "electronic funds transfer" for purposes of this Resolution means any transfer of funds, other than a transaction originated by check, draft or similar paper instrument, that is initiated through an electronic terminal, telephone, or computer or magnetic tape for the purpose of ordering, instructing, or authorizing a financial institution to debit or credit an account.

Section 3: Documentation. The Department of Finance and Records is required to maintain adequate documentation of the above-referenced transactions for future audits, as provided by law.
