## **ORDINANCE 2022-\_18\_\_**

## AN ORDINANCE TO ESTABLISH A HEALTH FUND (FUND 414) FOR THE TOWN OF ZIONSVILLE, INDIANA

WHEREAS, the Town of Zionsville ("Town") desires to establish a Health Fund 414 (a non-reverting fund) for the purpose of paying for Town of Zionsville employee health insurance claims, as well as other health insurance related expenses; and

WHEREAS, the Town Council of the Town (the "Council") desires to ensure that funds transferred from the General Fund #0101, MVH Fund 201, Wastewater Fund 606, Police Fund 271, and Payroll Fund 806 to the Health Fund 414 are used for the purpose of paying employee health insurance claims, as well as other health insurance related expenses.

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED** by the Town Council of the Town of Zionsville, Indiana as follows:

Section 1: **Fund Established.** The Town Council of the Town of Zionsville, Indiana, does hereby create Fund No. 414 which is designated as the Health Fund and shall be for the purpose of paying employee health insurance claims, as well as health insurance related expenses

Section 2: **Permitted Uses.** All money expended from the Health Fund shall be presented to Council once a month for confirmation of payments and is to be used exclusively for the purpose of paying employee health insurance claims, as well as other health insurance related expenses.

Section 3: **Internal Controls.** Internal controls shall be designated, implemented, and documented to provide reasonable assurance that the Health Funds will be safeguarded and used in accordance with this Ordinance.
