

ORDINANCE 2022- 19__

**AN ORDINANCE TO ESTABLISH A FLEXIBLE SPENDING ACCOUNT (FSA) FUND
(FUND 415)
FOR THE TOWN OF ZIONSVILLE, INDIANA**

WHEREAS, the Town of Zionsville (“Town”) desires to establish a Flexible Spending Account (FSA) Fund for the purpose of housing the funds from the employees’ payroll deductions (Payroll Fund 806) who are enrolled in this program; and

WHEREAS, the Town Council of the Town (the “Council”) desires to ensure that initial startup funds transferred from the Health Fund 414 to the FSA Fund 415 are used for the sole purpose of an enrolled employee’s FSA expenses. Future deposits to the FSA Fund 415 will be through payroll deductions (Payroll Fund 806) from the employees enrolled in the program.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED by the Town Council of the Town of Zionsville, Indiana as follows:

Section 1: **Fund Established.** The Town Council of the Town of Zionsville, Indiana, does hereby create Fund No. 415 which is designated as the Flexible Savings Account (FSA) Fund and shall be used for the sole purpose of enrolled employee’s FSA expenses.

Section 2: **Permitted Uses.** All money in the FSA Fund shall be used exclusively for the Federally-approved FSA expense guidelines for the employees enrolled in the program.

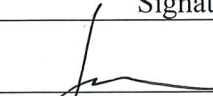
Section 3: **Internal Controls.** Internal controls shall be designated, implemented, and documented to provide reasonable assurance that the FSA Funds will be safeguarded and used in accordance with this Ordinance.

Introduced and filed on the 3rd ____ day of _October_____, 2022. A motion to consider on First Reading was sustained by a vote of _6_ in favor and _0_ opposed, pursuant to Indiana Code § 36-5-2-9.8.

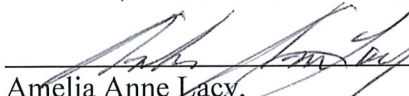
