

RESOLUTION NO. 2022- 18
OF THE TOWN OF ZIONSVILLE

**A RESOLUTION REGARDING
THE APPROPRIATION OF
ADDITIONAL FUNDS and AUTHORIZING THE TRANSFER OF FUNDS**

Whereas, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual Town of Zionsville budget.

Now, therefore, be it RESOLVED by the Zionsville Town Council of the Town of Zionsville, Boone County, Indiana, that for the expenses of the Town of Zionsville, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:

Funds noted above are available for additional appropriation via a November 1, 2022, cash balance in the General Fund of \$ 7,393,039.81.

Be it FURTHER RESOLVED that the remaining balance of the 2021 Park Improvements line item (101-44440-500-000-0) shall be moved to the Park Non-Reverting Capital Fund (403). This transfer is per Ordinance 10-1976, Ordinance 1987-16 and IC 36-10-3-20 as illustrated below:

IC 36-10-3-20(a) Upon the request of the board, the fiscal body of the unit may establish, by ordinance, a special non-reverting capital fund for the purposes of acquiring land or making specific capital improvements. The fiscal body may include in the board's annual budget an item and an appropriation for these specific purposes.

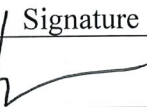
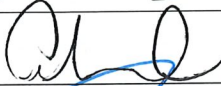
"The special non-reverting capital fund was to be funded from an item within the park & recreation board's annual budget with an appropriation made for 'these specific purposes'."

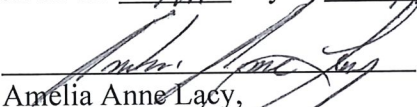
