**A RESOLUTION APPROVING AN
EMERGENCY MUNICIPAL SOLID WASTE, RECYCLABLE, AND
COMPOST COLLECTION AND DISPOSAL CONTRACT FOR
THE TOWN OF ZIONSVILLE, INDIANA**

WHEREAS, pursuant to the authority in Ind. Code 36-9-30 *et seq.*, the Town Council of the Town of Zionsville ("Town Council") issued a request for sealed bids pursuant to Ind. Code § 36-9-30-5 and Ind. Code § 36-9-30-5.3 for collection and solid waste disposal services and recycling services for the Town of Zionsville ("Town"); and

WHEREAS, on Monday, March 20, 2023 the Town Council, assisted by the Director of the Department of Public Works opened the sealed bids and announced the key terms of each sealed bid in a public meeting of the Town Council; and

WHEREAS, after reviewing the responsive bids the Town has determined the Priority Waste ("Priority") was the lowest responsive and responsible bidder and has selected Priority for a three (3) year initial contract with the Town which can be renewed for an additional three (3) year term locked in at the pricing structure of year three (3) of the contract ("Contract"); and

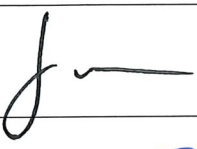
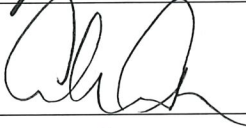
WHEREAS, pursuant to the Contract, Priority shall comply with the terms of the sealed bid that Priority submitted to the Town as well as applicable local, state and federal laws and regulations; and

WHEREAS, the Town Council passed Resolution 2023-08 declaring an emergency pursuant to Ind. Code § 36-1-12-9 authorizing the Town to enter into a short-term contract with a bidder with capability of providing service immediately upon the conclusion of the current contract with Waste Management ("WM") expiring on March 29, 2023 until such time that a final contract could be executed with the responsive bidder pursuant to the public bidding; and

WHEREAS, Priority was able to accommodate the Town and begin services immediately upon the conclusion of the WM contract; and

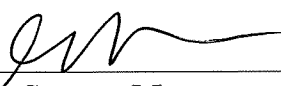
