479 These funds are from the Community Crossing Grant and are needed to complete the road rehab projects for 2023.

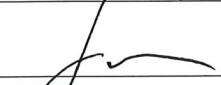
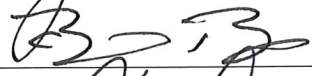
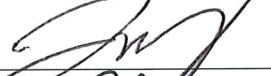
103 The Town received these funds from the Ice America fraud claim that was submitted to insurance. They are being appropriated so the funds will be available if it is determined that Ice America should be paid.

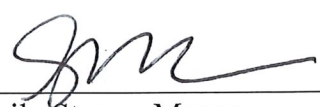

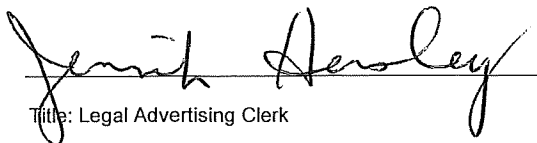
