- 276 The funds being appropriated are from the READi grant and are for the Gateway project.
- 271 The Police Dept is needing to make some repairs to the Municipal Building.
- 473 These funds will complete the restroom project at the Rail Trail trailhead.
- 103 The Parks Dept. is partnering with DPW to create a pathway from the Rail Trail to Trailside Elementary.
- **201** Capital DPW partnered with Boone Co for the reconstruction of their Templin Rd. bridge. This is the Town's portion.
- 201 Operating Supplies mid-block crosswalk signage.
- 101 The NTE \$15,000 is to contract BakerTilly for Internal Control Compliance in the Finance Dept.
- 101 The NTE \$20,000 is to contract BakerTilly to get the 2023 bank recs caught up
- 282 The Town has been asked to provide money to the ZYFL for the purchase of AED's
