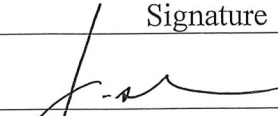
The funds being appropriated are from the READi grant and are for the Gateway project.

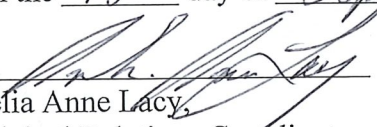

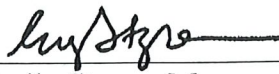
