OF THE ZIONSVILLE TOWN COUNCIL

**A RESOLUTION ESTABLISHING
A CROSSWALK LOCATION
IN ZIONSVILLE, INDIANA**

WHEREAS, Title VII, Chapter 70, §70.29 of the Zionsville Code of Ordinances authorizes the Town Council to designate crosswalks and establish safety zones, and

WHEREAS, the Big Four rail-trail serves as the major spine of the Town's multi-use pathway, connecting multiple areas to multiple facilities, and

WHEREAS, the Department of Public Works has incorporated the methodology of the IMUTCD to establish localized data thresholds and evaluation criteria to evaluate crosswalk locations when proposed for roadways classified locally by the Transportation Plan of the Town as *Collector* or higher, and

WHEREAS, Lemberger Drive is an internal public street within the Vonterra subdivision and is classified as a *local* street by the Transportation Plan of the Town, and

WHEREAS, the reasonably anticipated high volume of pathway users necessarily crossing a *local* street justifies a marked crosswalk.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Zionsville, Boone County Indiana that the Town Council formally establishes a crosswalk on and across Lemberger Drive at its intersection with the Big Four Rail Trail and directs the Department of Public Works to procure and install appropriate pedestrian crash countermeasures and undertake the necessary modifications to ensure compliance with applicable standards for construction.

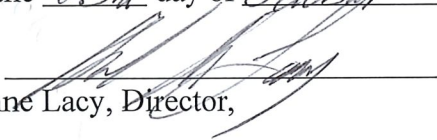
