

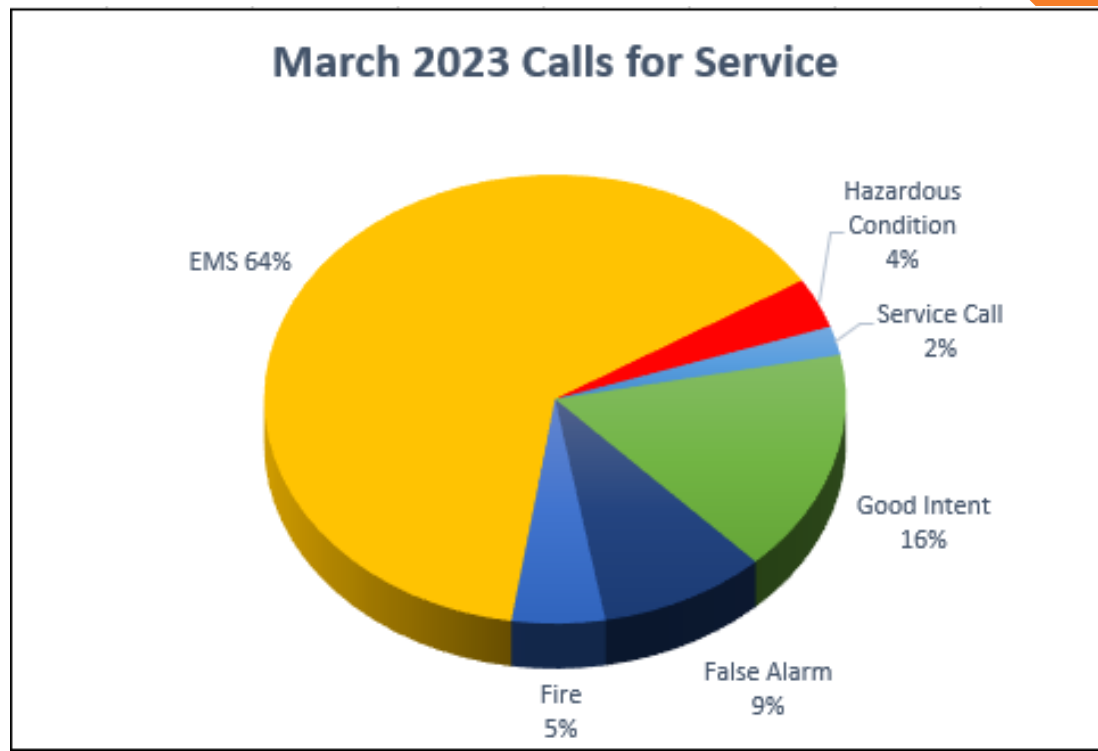

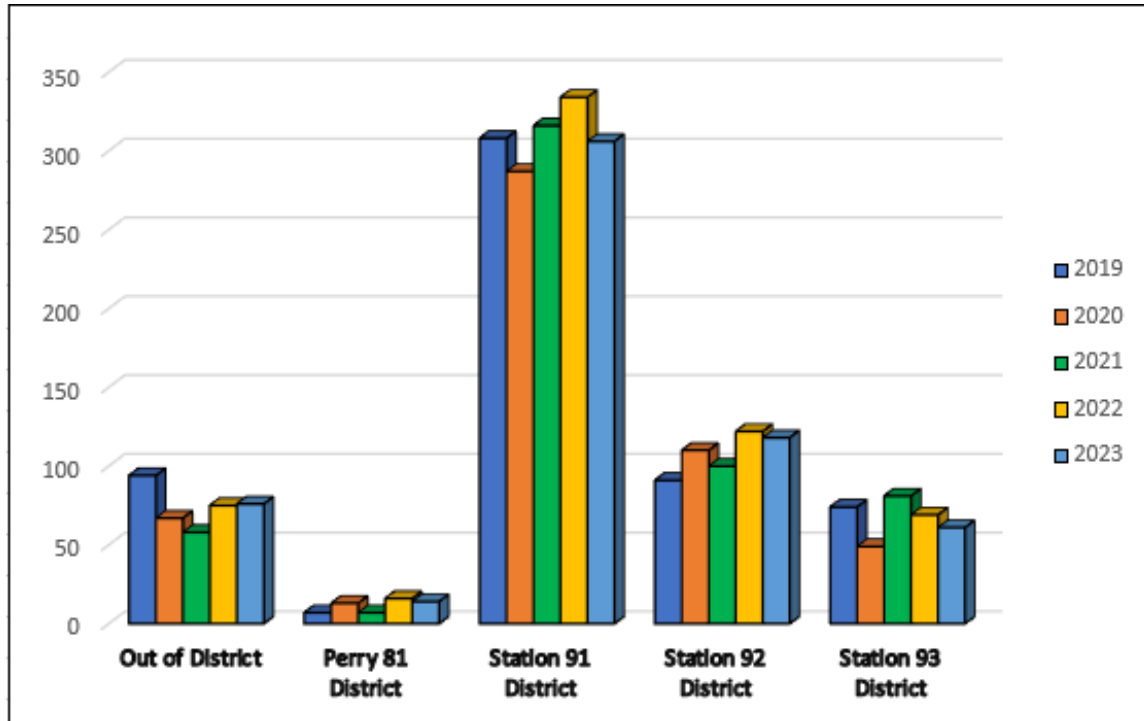

- Met with new recruits to provide welcome and introduction

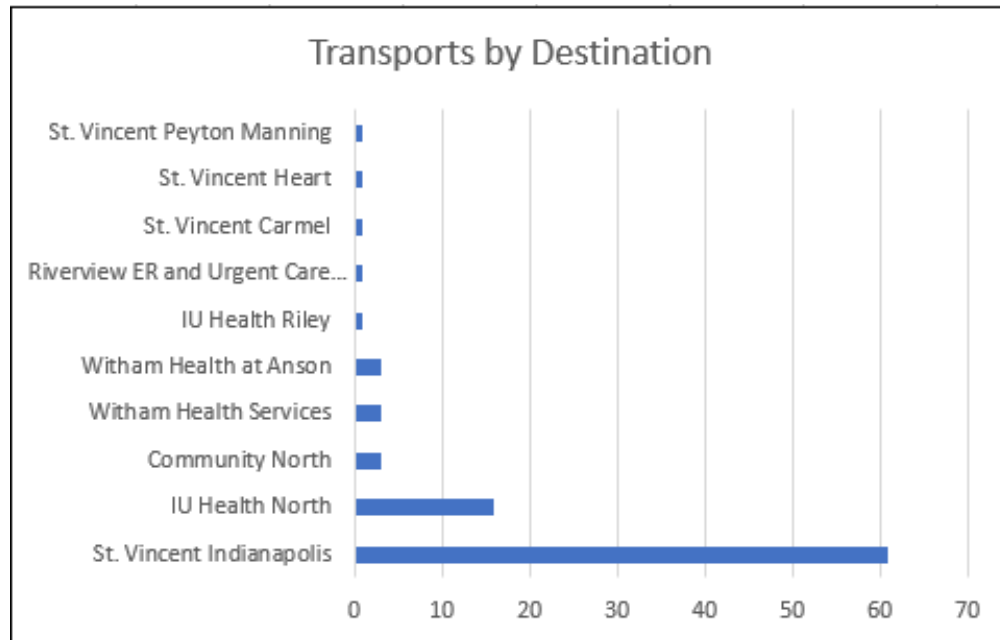

- Obtained mid-fidelity mannikin from Nassar Simulation Center (free)



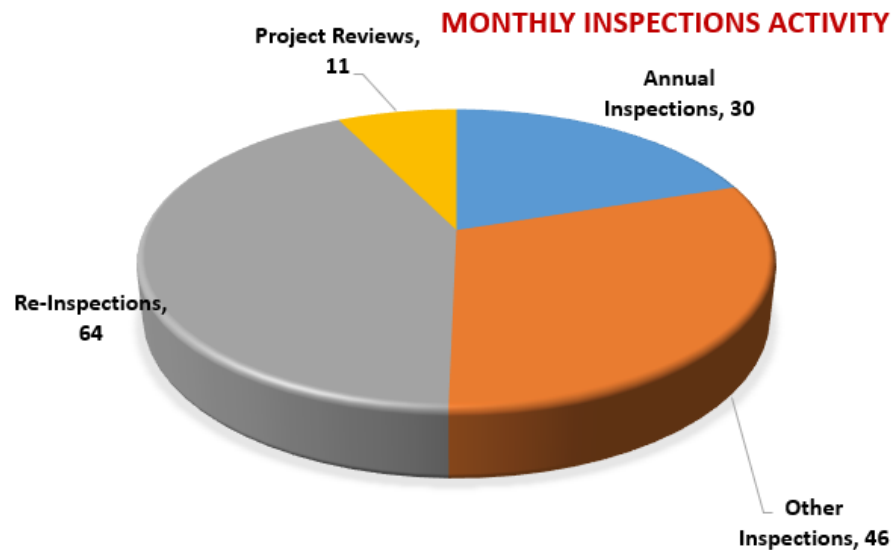
