The purpose of the additional appropriation for fund:

Court- The PT Court Administrator took on the duties of Public Assistance as well. This accounts for her extra hours. Her pay will be split between the 2 in 2024.

Finance – This is for Consulting.

CEDC – The \$124,000 is to apply Engineering fees that have been received and need adjusted to the line. All of the other amounts, Legal Fees -1,400, Supplies -1,400, Fuel -2,000, & Uniforms is due to the volume of work that went through the dept in 2023, as well as new employees.

Non-Departmental – \$116,000 Each year the Town budgets for property/casualty insurance, based on current year spend and input from brokers. This year the amount went up more than expected. \$40,000 The ADP monthly fees were taken out of the Bank Fees line in 2023. \$40,500 This is due to a payment made to the County for the municipal elections at Town Hall in 2023 and the amount due from the Workers Comp Audit.

Trash – The amounts in the trash fund are basically due to changes in timing of being billed by Priority. We previously were billed in the arrears vs. paying current which is what we are paying now. \$175,000. The \$25,000 is for Boone Co Solid Waste. Their fee is passed through our wastewater billing. We send them what we collect. This is new since changing trash providers. We did not have anything budgeted for a line to pay them.

Police Operating – The \$3,000 is a grant from Boone Co Solid Waste for the Teen Academy and needs to be appropriated to their line.

 \mathbf{CCD} – The police received an insurance check late last year for a totaled vehicle. It needs to be adjusted to the police vehicle line within CCD.

Fire Operating – The Fire Dept received a check in this amount for a tornado siren. They need it appropriated so they can get the siren and have it installed.

Police Continuing Ed – The Police Dept received a check in this amount from a grant to replenish the income lost from gun permit lost revenue.

Wastewater – The 2 items for wastewater are offsetting entries from reconciliations.
