## A RESOLUTION REGARDING THE APPROPRIATION OF ADDITIONAL FUNDS CHIEF LEGAL COUNSEL POSITION

WHEREAS, the Town of Zionsville, Boone County, Indiana ("Town") has historically outsourced all legal matters the Town; and

WHEREAS, the growth in population of the Town of Zionsville has led to significant demands within the administration for legal services; and

WHEREAS, the Mayor and the Town Administration has determined that hiring an inhouse Chief Legal Counsel to assist with the Town with legal matters on a full-time basis will benefit the Town; and

WHEREAS, the financial investment in an experienced in-house Chief Legal Counsel will lead to long-term efficiencies in legal projects for the Town, reduce the need for third party legal services, and ultimately lead to cost savings for the Town; and

WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the 2024 Town of Zionsville budget to allow the Town to fund the position of Chief Counsel.

**NOW, THEREFORE**, be it resolved by the Town Council of the Town, that for the expenses of the Town of Zionsville, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:
