**A RESOLUTION REGARDING
THE APPROPRIATION OF
ADDITIONAL FUNDS
GRANT WRITER POSITION**

WHEREAS, The Town of Zionsville, Boone County, Indiana (“Town”) has historically sought grants for the benefit of the Town; and

WHEREAS, the Mayor and the Town Council has determined that hiring an independent contractor to assist with identifying grant opportunities and seek grants on behalf of the Town will benefit the Town and services provided by the Town; and

WHEREAS, it has been determined that it is now necessary to appropriate more money than was appropriated in the 2024 Town of Zionsville budget.

NOW, THEREFORE, be it resolved by the Town Council of the Town, that for the expenses of the Town of Zionsville, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:
