**A RESOLUTION REGARDING
THE APPROPRIATION OF
ADDITIONAL FUNDS**

Whereas, it has been determined that it is now necessary to appropriate more money than was appropriated in the annual Town of Zionsville budget.

Now, therefore, be it resolved by the Zionsville Town Council of the Town of Zionsville, Boone County, Indiana, that for the expenses of the Town of Zionsville, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:

Fund 479 The purpose of the additional appropriation is return these funds to INDOT. As part of the Community Crossing Matching Grant (CCMG) any unused funds are to be returned to INDOT. The project was completed under budget.

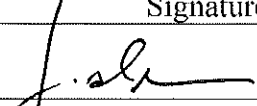
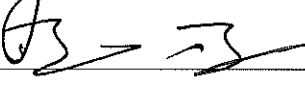
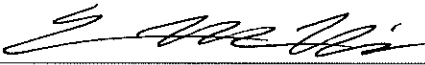
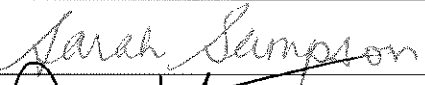
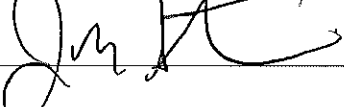
Fund 176 The purpose of the additional appropriation is to appropriate \$150,000.00 for engineering, design, and construction of multiple pathway project in the Town along Oaks St. This \$150,000.00 is part of the \$2,084,560 that was listed under "Investments in Surface Transportation Infrastructure Projects, Section 5 of the approved ARPA plan ordinance 2023-29. However, the \$150,000.00 was not included in the adopted ordinance 2023-43 when the other funds were appropriated.

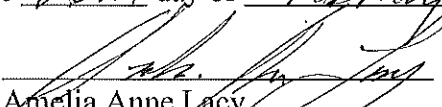

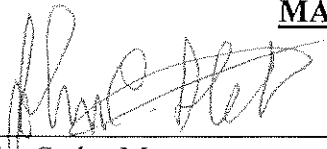
