## ORDINANCE 2024-09

## AN ORDINANCE AMENDING THE FUND NUMBER OF FUND NO. 276-READI GRANT

WHEREAS, in 2023, the Town of Zionsville, Indiana (the "Town") was awarded a Regional Economic Acceleration and Development Initiative Grant ("READI Grant") in the amount of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) that is to be used toward infrastructure improvement planning related to the Zionsville Gateway Project; and

WHEREAS, on May 1, 2023, the Town Council of Zionsville adopted Ordinance 2023-12, which established Fund No. 276-READI Grant (the "Fund") to receive and disburse the Town's READI Grant funds; and

WHEREAS, due to an error with the Town's accounting software when the Fund was established, it was overlooked that the Town had previously created a Fund No. 276, which is currently dormant; and

**WHEREAS**, due to the already-existing dormant Fund 276, it is now necessary to amend the Fund's number to 275.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Zionsville, Indiana, as follows:

**Section 1:** The foregoing Recitals are incorporated herein by this reference.

**Section 2:** Fund No. 276- READI Grant is hereby amended to Fund No. 275- READI Grant.

**Section 3:** The remaining provisions of Ordinance 2023-12 are not affected by this Ordinance and shall remain in full force and effect.

**Section 4:** This Ordinance shall be in full force and effect from and after its passage by the Town Council and approval by the Mayor.
