

AN ORDINANCE AMENDING THE FUND NUMBER
OF FUND NO. 276-READI GRANT

WHEREAS, in 2023, the Town of Zionsville, Indiana (the “Town”) was awarded a Regional Economic Acceleration and Development Initiative Grant ("READI Grant") in the amount of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) that is to be used toward infrastructure improvement planning related to the Zionsville Gateway Project; and

WHEREAS, on May 1, 2023, the Town Council of Zionsville adopted Ordinance 2023-12, which established Fund No. 276-READI Grant (the “Fund”) to receive and disburse the Town’s READI Grant funds; and

WHEREAS, due to an error with the Town’s accounting software when the Fund was established, it was overlooked that the Town had previously created a Fund No. 276, which is currently dormant; and

WHEREAS, due to the already-existing dormant Fund 276, it is now necessary to amend the Fund’s number to 275.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Zionsville, Indiana, as follows:

Section 1: The foregoing Recitals are incorporated herein by this reference.

Section 2: Fund No. 276- READI Grant is hereby amended to Fund No. 275- READI Grant.

Section 3: The remaining provisions of Ordinance 2023-12 are not affected by this Ordinance and shall remain in full force and effect.

Section 4: This Ordinance shall be in full force and effect from and after its passage by the Town Council and approval by the Mayor.

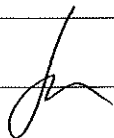
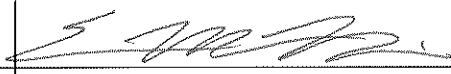
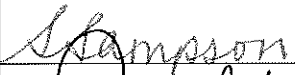
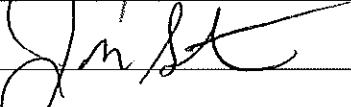
Ordinance 2024-09

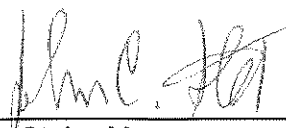
