ORDINANCE 2024-14

AN ORDINANCE ADDING TITLE III, CHAPTER 34, SECTION 34.04 TO THE ZIONSVILLE TOWN CODE

WHEREAS, on August 21, 2023, the Zionsville Town Council (the "Town Council") adopted Ordinance 2023-16, which revised and updated various Town fee schedules; and

WHEREAS, Ordinance 2023-16 contained a provision stating that specific fee amounts were to be deleted from the Town Code and that individual sections containing fees should instead reference the Town of Zionsville Fee Schedule, which may be amended from time to time; and

WHEREAS, in order to enhance the clarity and useability of the Town Code, the Town Council finds that it would be beneficial to establish a general reference to the Town's fee schedule within Town Code.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Zionsville, Indiana, as follows:

Section 1: The foregoing Recitals are incorporated herein by this reference.

<u>Section 2</u>: Title III, Chapter 34, Section 34.04 is hereby added to the Town of Zionsville Code of Ordinances and shall read as follows:

"§ 34.04 TOWN FEE SCHEDULE INCORPORATED BY REFERENCE

The Town of Zionsville Fee Schedule is hereby incorporated by reference as if set forth fully herein. Copies of the Town's Fee Schedule, as it may be amended from time to time, are available to the public in the Department of Finance and Records during regular business hours or on the Town's website."

<u>Section 3</u>: This Ordinance shall be in full force and effect from and after its passage by the Town Council and approval by the Mayor.
