## ORDINANCE 2024-23 OF THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, INDIANA

## AN ORDINANCE ESTABLISHING DONATION FUNDS FOR THE TOWN OF ZIONSVILLE POLICE DEPARTMENT, FIRE DEPARTMENT AND PARKS AND RECREATION DEPARTMENT

WHEREAS, the Town Council of the Town of Zionsville, Indiana (the "Town Council") previously established Fund 2300 - Donation Fund to receive donations made to the Town of Zionsville, Indiana (the "Town"); and

WHEREAS, in order to more easily account for donations made to the Town, it is in the best interest of the Town to establish separate donation funds to receive and disperse donations made to various Town departments.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Zionsville, Indiana, as follows:

**Section 1:** The foregoing Recitals are incorporated herein by this reference.

**Section 2:** Fund 2300, Donation Fund is hereby amended to Fund 2300 - Police Donation Fund.

**Section 3**: There is hereby established Fund 2301 – Fire Department Donation Fund and Fund 2302 – Parks and Recreation Donation Fund.

**Section 4**. The Departments may accept donations for their respective donation fund from persons acting in their individual capacity, from business organizations and corporations, and from not-for-profit organizations and service groups.

**Section 5:** The Director of Finance & Records is directed to transfer donations currently housed in Fund 2300 – Donation Fund into Fund 2301 and Fund 2302 as appropriate.

**Section 6:** The provisions of this Ordinance shall take effect following the date of its passage and action by the Town Council and the Mayor in the manner prescribed by Reorganization section ZR2A18 and shall remain in full force and effect until amended or repealed by ordinance of the Town Council.
