## AN ORDINANCE ABOLISHING DORMANT FUND 2420 - TASK FORCE - POLICE

**WHEREAS**, the Town Council of the Town of Zionsville, Indiana (the "Town Council") previously established Fund 2420 - Task Force – Police in order to separately account for funds received police overtime reimbursements (the "Fund"); and

WHEREAS, the Fund has not had any activity since 2009; and

WHEREAS, it is the best interest of the Town of Zionsville ("Town") to terminate the dormant Fund and distribute the Fund's remaining balance of \$26,477.21 into Fund 1271 - Police Operating Fund.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Zionsville, Indiana, as follows:

- **Section 1:** The foregoing Recitals are incorporated herein by this reference.
- **Section 2:** Fund 2420 Task Force Police is hereby abolished.
- **Section 3:** The Director of Finance & Records is directed to transfer the remaining balance of Fund 2420, \$26,477.21, into Fund 1271 Police Operating Fund.
- **Section 4:** The provisions of this Ordinance shall take effect following the date of its passage and action by the Town Council and the Mayor in the manner prescribed by Reorganization section ZR2A18 and shall remain in full force and effect until amended or repealed by ordinance of the Town Council.
