

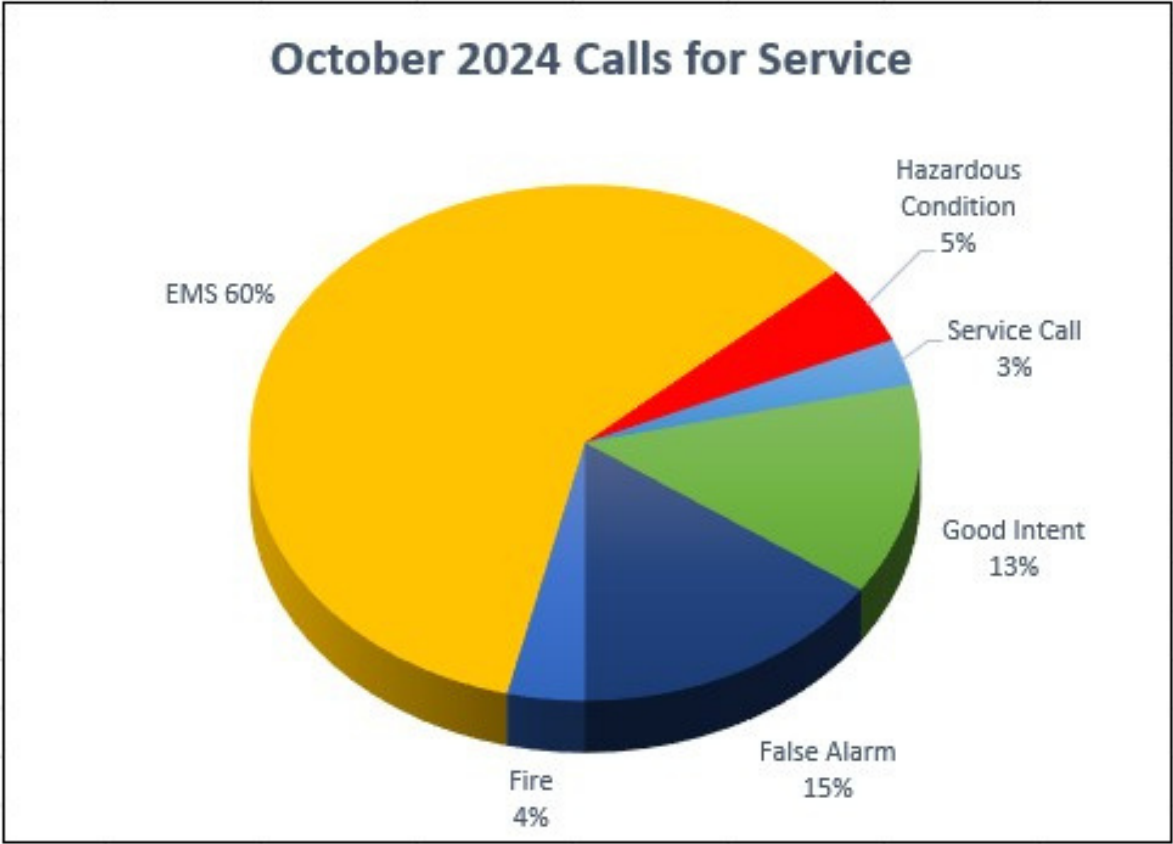

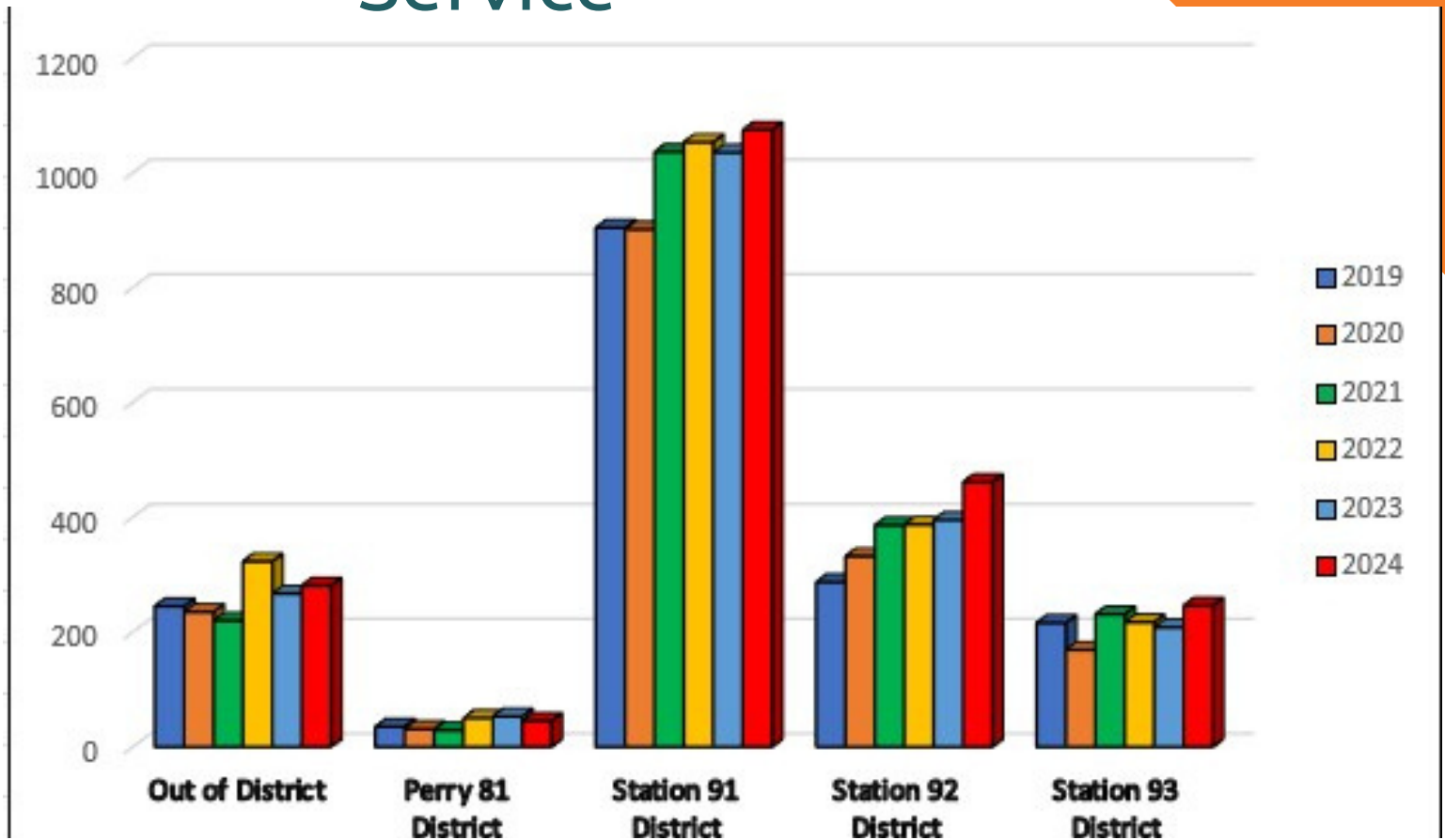

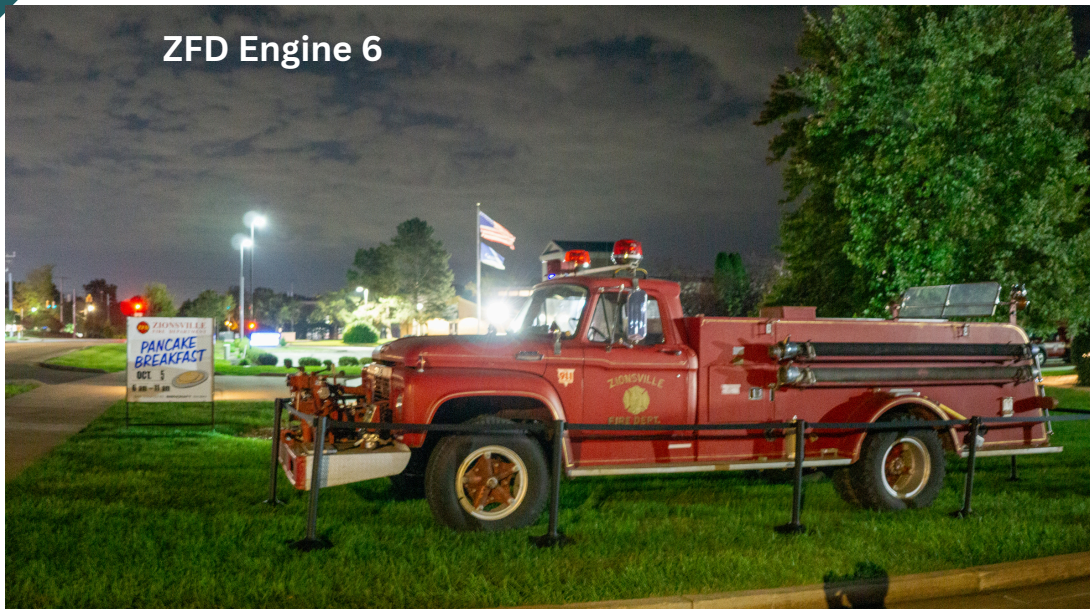
YTD Calls for Service

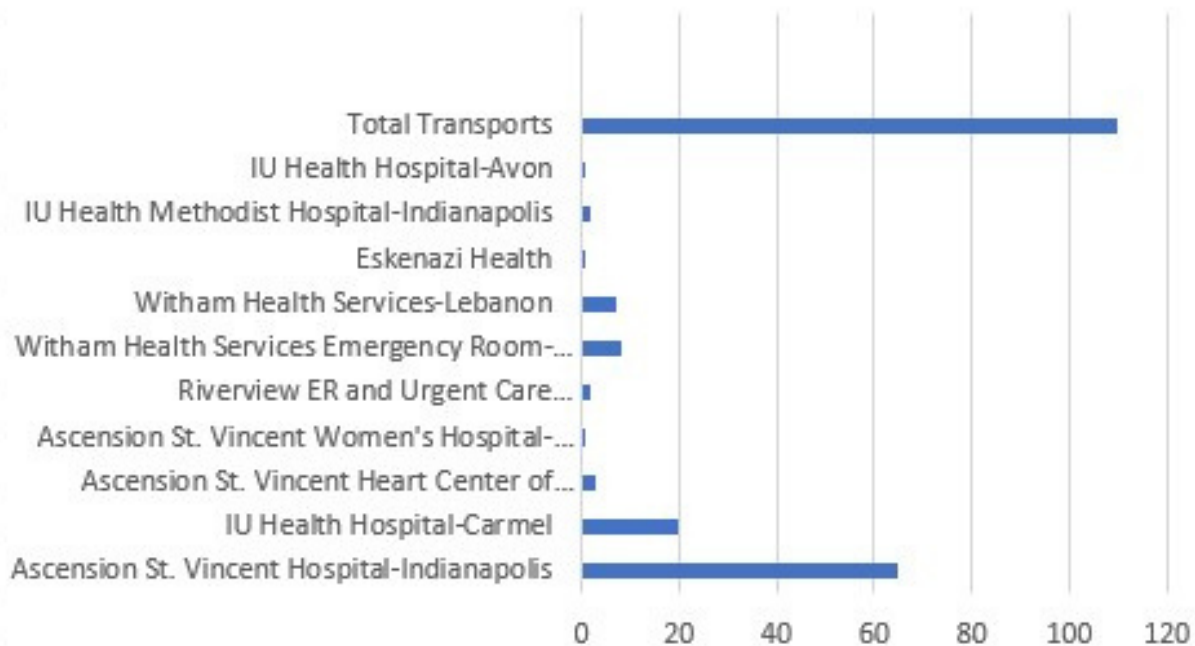

- Began preparation for December EMS training – Ascension St. Vincent skills

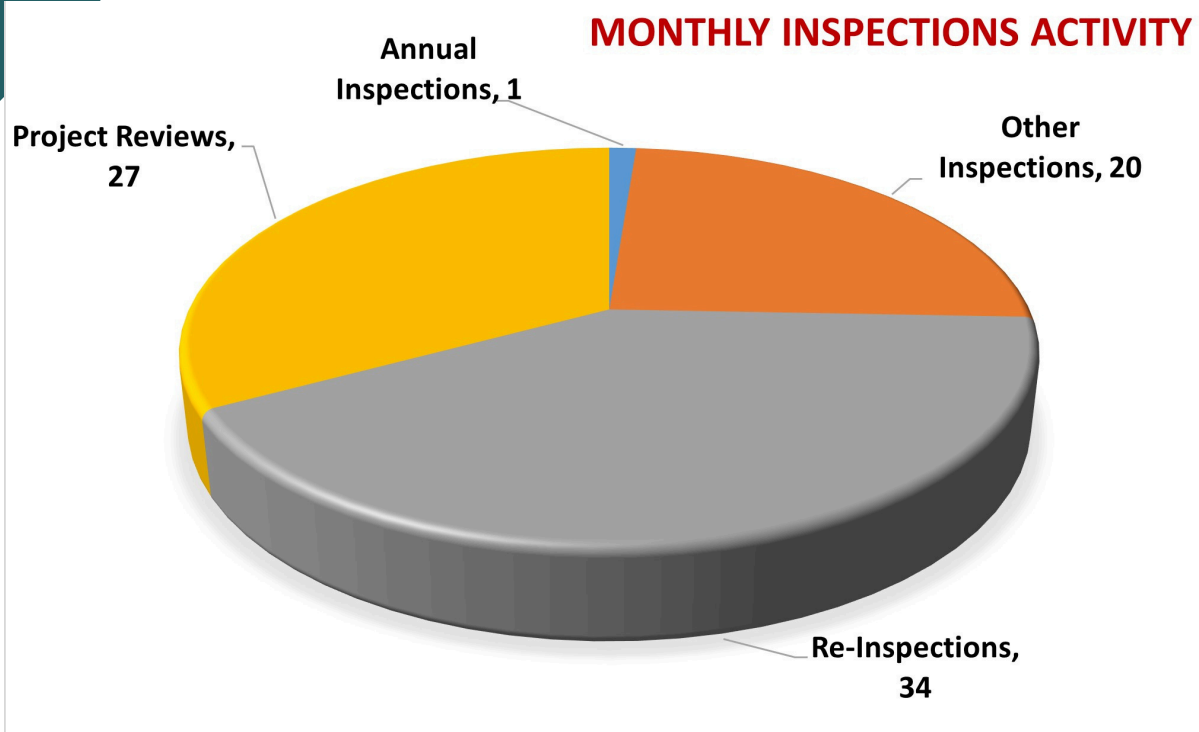


Drills at Hoosier Village 9.19.2024

- Conducted Live Fire Training for Citizens Fire Academy

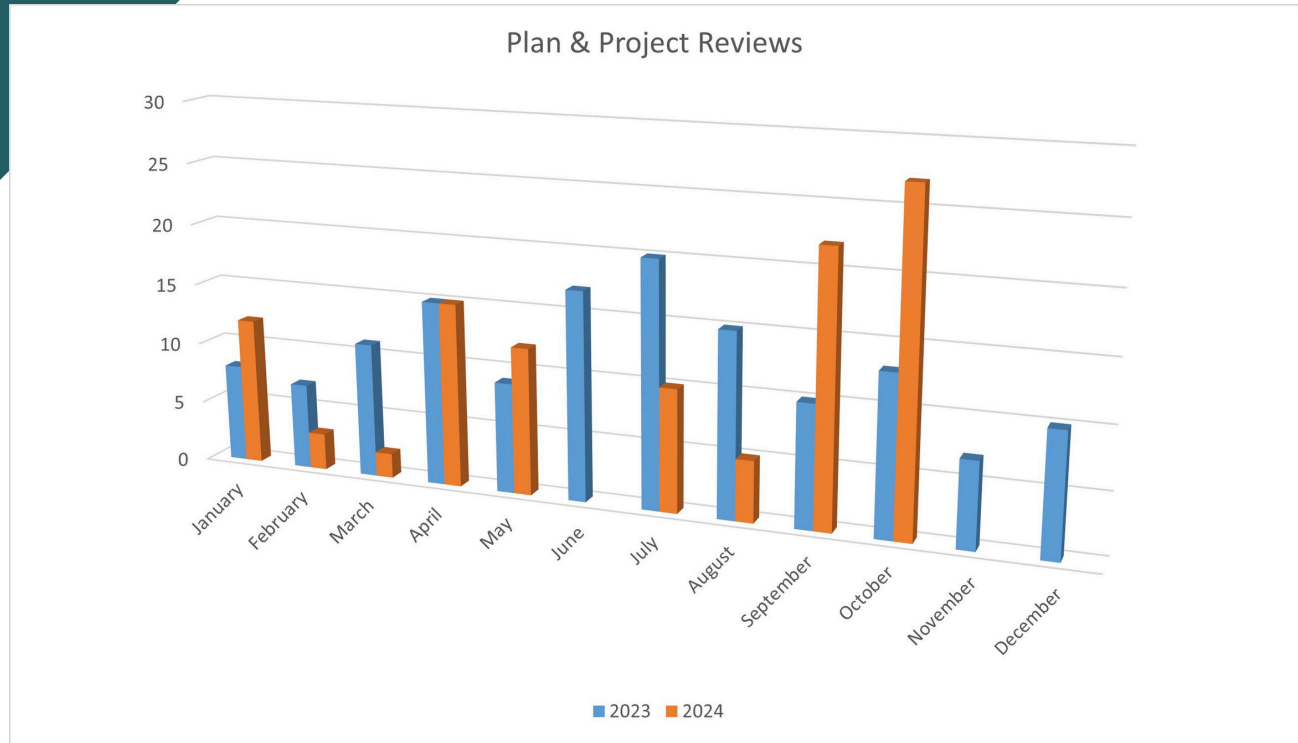
