**RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, INDIANA,
RECOGNIZING THE ZIONSVILLE GIRLS GOLF TEAM AND TAYLOR SNIVELY ON
THEIR STATE CHAMPIONSHIPS**

WHEREAS, On October 5, 2024, the Zionsville Community High School's varsity girls golf team (the "Zionsville Girls Golf Team") won the Indiana High School Athletic Association ("IHSAA") 52nd annual state championship at Prairie View Golf Club in Carmel, Indiana; and

WHEREAS, The Zionsville Girls Golf Team shot 627, five strokes ahead of the runner-up Noblesville, to claim the state championship; and

WHEREAS, This is the Zionsville Girls Golf Team second state championship, and first since 2018; and

WHEREAS, The Zionsville Girls Golf Team consists of Kaitlyn Adler, Paige Henney, Hensley Kriebel, Avery Lewis, Taylor Snively, and Amaya Wade; and

WHEREAS, Along with the team success of the Zionsville Girls Golf Team, Zionsville freshman Taylor Snively also claimed the individual state title, making her only the third freshman in the 52-year history of the IHSAA finals to claim such honors. Snively is the first individual champ to play for the team champion since 1999; and

WHEREAS, The Zionsville Girls Golf Team is coached by Maggie Nobbe, a former player of the Zionsville Girls Golf Team that won its first state championship in 2018. This was Nobbe's fifth season as head coach of the team, and first state championship title as head coach; and

WHEREAS, The success of the Zionsville Girls Golf Team was a result of a season-long collaborative effort involving the players, coaches, and parents; and

WHEREAS, The Town of Zionsville, Boone County, Indiana ("Town") strives to support and celebrate the accomplishments of its citizens and its community; and

WHEREAS, The student-athletes of the Zionsville Girls Golf Team have devoted countless hours this season to balancing their school work and sports commitment, and should be commended on their dedication to both academics and athletics; and

WHEREAS, The Town would like to use this Resolution as an opportunity to recognize the Zionsville Girls Golf Team in winning the IHSAA state championship.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Zionsville, Boone County, Indiana, that:

Section 1. The Town of Zionsville, Boone County, Indiana (“Town”) recognizes and congratulates the Zionsville Community High School’s varsity girls golf team in winning the Indiana High School Athletic Association (“IHSAA”) 52nd annual state championship.

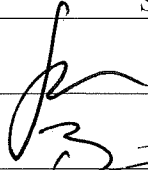
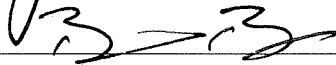
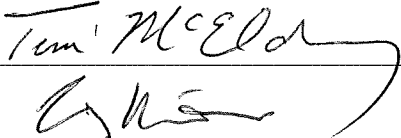
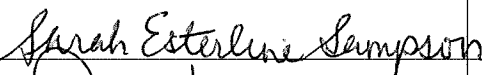
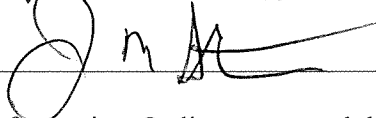
