ORDINANCE 2025-14 OF THE TOWN COUNCIL OF THE TOWN OF ZIONSVILLE, INDIANA

AN ORDINANCE ADDING TITLE V, CHAPTER 52, SECTION 52.003 TO THE ZIONSVILLE TOWN CODE

WHEREAS, the Town of Zionsville ("Town") owns and operates a sewer works utility pursuant to Indiana Code § 8-1.5-3-1 *et seq.* (the "Utility"); and

WHEREAS, it is occasionally necessary to revise and update the wastewater construction standards that are used by the Utility; and

WHEREAS, to enhance the operating efficiency of the Utility, the Town Council of the Town ("Town Council") now finds that delegating the authority to approve wastewater construction standards to the Director of the Department Public Works will create efficiencies for the Town and is in the public interest.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Zionsville, Indiana, as follows:

Section 1: The foregoing Recitals are incorporated herein by this reference.

Section 2: Title V, Chapter 52, Section 52.003 is hereby added to the Town of Zionsville Code of Ordinances and shall read as follows:

"§ 52.003 WASTEWATER CONSTRUCTION STANDARDS.

The Director of the Department of Public Works is hereby authorized to approve wastewater construction standards for the Town of Zionsville, Indiana Sewage Works."

Section 3: If any portion of this Ordinance is for any reason declared to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portions of this Ordinance so long as enforcement of same can be given the same effect.

Section 4: The provisions of this Ordinance shall take effect following the date of its passage and action by the Town Council and the Mayor in the manner prescribed by Reorganization section ZR2A18 and shall remain in full force and effect until amended or repealed by ordinance of the Town Council.
