**A RESOLUTION REGARDING
THE APPROPRIATION OF
ADDITIONAL FUNDS**






- Hampshire Road Fund of \$249,654.00

1. Funding improvements to CR 400 S. and CR 500 S. per the recorded commitments of the Hampshire subdivision.
2. Funding the required study to update the Road Impact Fee Ordinance.
3. Refunding partial road impact fee payments to Aria Zionsville, LLC for a road impact fee reduction as approved by the Road Impact Fee Review Board.
