5. The OWNER/CONTRACTOR AFFIRMS AND AGREES TO THE FOLLOWING:

Installation or repairs of building sanitary sewer shall be per the specifications of the Town of Zionsville Design & Construction Standards and any conditions noted below. All work shall be inspected by Town of Zionsville personnel during "open trench" phase and before backfilling. **NO footing or foundation drains, or other sources of ground or stormwater, shall be permitted to enter the Town's sanitary sewer system.** The permit holder (property owner, developer or contractor) shall be responsible for damages to the Town's sanitary sewer system, including manholes, casting, manhole lids and the like, caused by construction activity on the building site which is the subject of this permit.

Inspections by the Town of Zionsville are **MANDATORY**. Please call 317 873-8247 prior to 7am for inspection. Inspection requests placed after 7am will be scheduled the following business day. **Sewer bursting/lining require video submittal to inspectors within (10) business days of permit issuance for review and approval.**

By signing below, I attest that I am familiar with the Town of Zionsville Design & Construction Standards and agree to accept responsibility for all work done under this permit.
